4. RULES

4.1. COMPETITION RULES: W.T.F. Competition rules.

4.2. MODE:

Individual system. There will be 3 Competition Areas, all of them with electronic score board system and Lajust body protectors.



4.3. AWARDS:

- INDIVIDUALS: 1st. 2nd. and two 3rd. Places.
- COUNTRIES: 1st, 2nd. and 3rd. Places

4.4. EQUIPMENT:

Electronic body protector (**LAJUST**) and head gear will be provided by the organizer. Groin, hand, forearm, and shin protectors will be brought by the contestants which is compulsory (hand protectors and mouth protectors will be, also, compulsory)

4.5. PROTEST:

Only de Head of Team is allowed to protest immediately after the end of the contest. An amount of **100 USD** has to be pay for each protest.

4.6. LIABILITY:

All competitors are considered to participate at their own risk. Azerbaijan Taekwondo Federation and the organizer assume no responsibility for any damages, injuries or losses.

5. ENTRY

5.1. APPLICATIONS:

All the applications forms must be completed at the enclosed official form. Deadline **15th May 2010.**

5.2. ENTRY FEE:

ENTRY FEE IS **40 USD PER COMPETITOR.**

6. HOTEL ORGANIZATION

6.1. Accommodation charges should be paid by the participating teams. The price list of hotels is shown in attachment to the application.



7. TRANSPORTATION

The Organizing Committee will provide transportation, to all countries which inform us the dates and flight schedule, from the Airport to the Hotel and from the Hotel to the Airport.

- Azerbaijan Taekwondo Federation will pay the accommodation charges for the International referees, full board.
- The Organizing Committee will pay the referees the total amount of **50 € per day** to officiate the championships.

9. VISA ISSUES

All participating teams who will need to get visa to enter Azerbaijan Republic, should send the passport copies of the team members **by 10.05.2011**

- It is the responsibility of each National Team to bring (2) National Flags and (1) CD of national anthem.
