referee. We kindly ask referees to register themselves at "referee-lausanne@hotmail.com". All referees will stay at the same hotel. Referee meeting is scheduled on Friday, May 20<sup>th</sup>, 2011 at

21:30 at the Referee hotel.

**Conditions for Referees:** Round trip airfare shall be born by each participating referee. The

Organizing Committee will cover Hotel and Full board accommodation from Friday May 20th (check in from 16:00) until

Monday May 23<sup>rd</sup> (check out before noon). The allowance will be 100 CHF for 2 days.

Coach: For every 5 contestants within the same team, one coach is
