PARTICIPATION REQUIREMENTS:

All participants must meet the following:

1. This is an Open Tournament for all Taekwondo practitioners from 12 years old and up. Competitors must be at least 4th Gup to participate in the event.

AFFILIATES:

All participants must be nationals of the country they represent and must present an endorsement note from their MNA.

COMPETITION RULES:

WTF Competition Rules will be in effect.

AGES:

Cadets: born 2003
 Junior: born 2000
 Senior: 18 years old.
 Ultras: 35 years and up.

EQUIPMENT:

The organization will provide the PSS for all athletes; however, all athletes must provide their own electronic foot protectors for competition. The PSS system will be used from the Cadet category and up. (All belts)

All athletes are responsible for their own protective headgear, gloves, feet, groin, arm and shin guards and mouth guards.

OFFICIAL UNIFORM: (DOBOK)

All competitors must wear a WTF recognized Taekwondo white "V" neck uniform (Dobok) in good condition. Black Belts must wear uniforms with black collar and color belts must wear uniforms with white collar.

Patches, embroidery, logos, team names, country, Athlete's name and stripes are allowed on the uniform, but no tape is permitted in any part of the uniform.

PROTECTIVE EQUIPMENT:

Athletes must wear approved protective equipment as headgear (only red and blue will be allowed) before entering the contest area. Head protector must be firmly placed under the left arm to enter the competition area and shall place it on the head following the referee's instructions before beginning competition. Groin, forearm and upper arm protection, should be worn inside the Taekwondo uniform.

Using any other item on the head other than the head protector is not allowed. A previously approved religious item must be worn under the headgear and shall not cause damage or obstruction to the opponent.

REGISTRATION FEES, TERMS AND CONDITIONS OF PARTICIPATION:

- 1. Air fares, food and lodge must be paid by all participants.
- 2. \$ 100.00 Fee for international participants.
- 3. \$ 60.00 Fee for domestic participants.
- 4. \$ 300.00 Fee for coaches without certification / Free of charge for coaches with PATU's certification

REFEREES:

1. P.A.T.U. will appoint the required number of Referees.

2Each international Referee will pay for their round-trip flight.

- 3. The Organizing Committee will cover five nights of food and lodging.
- 4. The Organizing Committee will provide each International Referee \$ 100.00 per diem for 3 days of competition and 1 day of technical congress, weighing and refreshment.

WEIGH-IN:

- 1. Weigh in of athletes must be completed the day before the day of competition.
- 2. In weigh in the competing males can wear underwear and competing women can wear underwear and bra.

Athletes can weigh in naked if you prefer.

GROUND TRANSPORT:

Ground transportation is the sole responsibility of the participants.

REGISTRATION FORMS AND DEADLINES FOR REGISTRATION:

Registration is done through the GAL / WTF system (Mandatory as of March, 2014) IMPORTANT: All participants **must meet this requirement one month before the closing date** for registrations for the event to avoid problems later.

"The WTF Global License is a mandatory taekwondo passport to participate in all WTF and Continental Union recognized Tournaments for all athletes and officials.

To receive an event credential onsite and participate, an approved WTF Global License in the form of the license card is required upon onsite check in.

WTF Global License registrations & renewals can only be made through the WTF recognized Member National Associations and application should be made at least 1 month before the tournament starts to ensure the license can be processed and approved in time".

Onsite registration for a WTF Global License is not possible and those without proof of a WTF Global License may be refused participation"
