6. COMPETITION RULES

WT Competition Rules shall be applied.





7. METHOD OF COMPETITION

- i. Single elimination system including Bronze medal contest
- ii. Grade: G8
- iii. Number of Courts: Two (2)
- iv. Number of athletes: Maximum 16 per division
- v. Selection of athletes: Top 16 athletes per Olympic category based on the WT Olympic ranking published in November 2017. The last event before release of this ranking will be the Kimunyong Cup International Open Taekwondo Championships (October 28th November 1st)
- vi. Maximum quotas per MNA: 2 athletes per weight division
- vii. Host Country: One (1) athlete from the host country shall be invited in weight division(s) where host country athlete was not invited through WT Olympic ranking in November 2017. There is no host country seeding for GP Final.
- viii. Seeding and drawing of lots: All ranked athletes based on WT Olympic Ranking of November shall be seeded accordingly.

ix. Confirmation timeline

- WT will send out the invitation to the pertinent MNA first week of November.

- The invited MNA is requested to send written confirmation on participation of its athlete(s) to WT sport department via <u>sport@wtf.org</u> no later than November 14th. After the MNA confirms participation via e-mail, MNA shall register the athlete(s) through online registration system, simply compete.

- If a MNA withdraws participation of its athlete(s), he/she will be replaced by the next highest ranked athlete of the WT Olympic Ranking (November version).

- If registered athlete does not participate in GP Final without prior notice to the WT sport department by 5:00 pm in Swiss Time, November 24th, he or she won't be invited for next GP Final regardless of their WT Olympic ranking

10. CONDITIONS FOR PARTICIPATING TEAMS

Round-trip Airfare and Accommodation

Round trip airfare and accommodation charges of room and board shall be borne by the participating National Association

To register, an athlete is required to be in the proper physical condition to compete in Abidjan 2017 GP Final. Any athlete who withdraws after weigh-in will be subject to an investigation as to whether or not the withdrawal was in bad faith. (Bad faith includes, but is not limited to, having an prior illness or injury such that it was unreasonable to expect the athlete to be able to compete at the time of the weigh-in.) The burden will be on the athlete to demonstrate that the withdrawal was not in bad faith. If the investigation panel determines that the withdrawal was in bad faith the athlete will be suspended for up to 6 months, and the athlete and members of the athlete's entourage may be subject to an additional Ethics investigation.

11. WT GLOBAL LICENCE & ONLINE REGISTRATION

All Athletes and Team officials must FIRST be registered with a WT Global Athlete Licence (GAL) or Global Official Licence (GOL).





i. WT Online Registration

Online National Team Entry will only be accepted through the WT online registration system, simply compete and registration is only possible with a valid WT Global Licence. National Team GMS admins will be notified via email once online registration is open.

12. ENTRY FEES

The OC shall collect the entry fees from the participating national teams. The national team shall pay an entry fee to the Organizing Committee by cash in US\$ only at the WT Registration Center in Abidjan prior to the start of the competition. Athletes shall not be allowed to compete without successful payment of entry fee to the Organizing Committee.

<u>REGULAR ENTRY FEES</u>: The national teams completing their registration during this period will be charged the regular registration fee.

- US \$100 per athlete.
- Regular entry fee period will begin on **November 2nd 2017, 17:00 Local Swiss Time.**
- Regular entry fee period will end on **November 14th 2017, 17:00 Local Swiss Time.**

<u>Quota Completion Entry Fees</u>: The national teams who are informed regarding the remaining quotas in each category after the end of Regular Registration will be charged the regular registration fee.

- US \$100 per athlete.
- Quota Completion fee period will begin on **November 15th 2017, 17:00 Local Swiss Time.**
- Quota Completion fee period will end on **November 24th 2017, 17:00 Local Swiss Time.**

13. ENTRY DEADLINES & IMPORTANT DATES

- i. Entry deadline for Regular Registration Period is **November 14**th, 2017 17:00 Local Swiss Time. Entry submission after this date will be not accepted under any circumstances.
- ii. Entry deadline for Quota Completion Registration Period is **November 15th**, 2017 17:00 Local Swiss Time. Registration after this date will be not accepted under any circumstances.
- iii. In case of replacement of an injured athlete, an MNA may replace this athlete no later than November 24th, 2017 17:00 Local Swiss Time
- iv. The registered athletes (only injured athlete) or team officials may be replaced **without any penalty** until **November 24th, 2017**.
- v. Entry fee of US\$100 per athlete will not be charged in case of cancellation of participation until November 24th Entry fee must be paid in case of the cancellation of participating athletes after November 24th or no-show.
 - Athletes: Member national associations have to submit entry online by logging into the WT GMS for the athletes invited by the WT. A member national association can send a maximum 2 athletes per weight division provided that these athletes are the ones invited by the WT. No additional athletes are accepted. No reserve athlete is accepted. No entry will be accepted or modified at the accreditation center(s) in Abidjan.
 - Team officials: Member national association have to register online by logging in to the WT GMS for maximum one (1) Head of team per country, one (1) manager per team, two (2) coaches per team, one (1) team doctor per team, two (2) trainers per team.
 - MNA officials: three (3) Member National Association (MNA) officials per country can be registered online by logging in to the WT GMS.
 - Penalty: Penalty of US\$100 per person shall be paid to the Organizing Committee at the accreditation center in Abidjan in the following cases.
 - 1) Any team official who is not registered online wants to be accredited at the accreditation center in Abidjan although the total number of team officials does not exceed the designated number,
 - In case of exceeding designated number of MNA officials wants to be accredited at the accreditation center in Abidjan or any MNA official who is not registered online wants to be accredited at the accreditation center in Abidjan.
 - Any changes or additions that are made to a national team list after **November 24th** will be charged a US\$100 penalty in addition to the registration fees. This penalty will be considered the onsite fee for





approved additions or changes to the national team list.

• Any WT Global Licence registration completed <u>onsite</u> will be charged a US\$30 onsite processing fee for each WT Global Licence required.

14. CLASSIFICATION OF RESULTS

Medals will be awarded to the top three athletes in the respective weight category of the pertinent championships:

1 st PLACE:	USD 6'000, GOLD MEDAL & CERTIFICATE
2 nd PLACE:	USD 3'000, SILVER MEDAL & CERTIFICATE
3 rd PLACE:	USD 1'000, BRONZE MEDAL & CERTIFICATE

All athletes will get ranking point. The points will be reflected on WTF World Ranking and WTF Olympic Ranking. The ranking points per winners of the championships shall be allocated as follows.

16. INTERNATIONAL REFEREES

The WT will appoint a total of 40 International Referees. The appointed international referees shall officiate at the Abidjan 2017 World Taekwondo GP Final & World Taekwondo Team Championships; the following conditions shall apply:

- i. International Referees are required to pay for their own roundtrip airfares.
- ii. The Organizing Committee shall pay for the expenses for eight (8) nights' stay of room and board. Check-in: November 29 / Check-out: December 7
- iii. The Organizing Committee shall pay a per diem of US\$100 to the selected International Referees for competition period (total five days; US\$500 per referee including Team Championships)

17. TECHNICAL DELEGATE AND COMPETITION SUPERVISORY BOARD

The WTF will appoint one (1) Technical Delegate and up to four (4) members of the Competition Supervisory Board. The following conditions shall apply:

- i. The Organizing Committee shall pay for the expenses for up to eight (8) nights' stay of room and board. Check-in from: November 29 / Check-out: December 7
- ii. The Organizing Committee shall pay a per diem of US\$100 to the Technical Delegate and the members of the Competition Supervisory Board for competition period (total five days; US\$500 per person including Team Championships).

18. WT-RECOGNIZED TAEKWONDO UNIFORM (DOBOK) AND PROTECTIVE EQUIPMENT

- i. Daedo Protector and Scoring System (PSS) including Head PSS will be used for the competition.
- ii. Participating contestants are required to wear WT-recognized doboks and WT-recognized protective





equipment. The latest version of WT-recognized manufacturers' list is available at the website of WT (<u>http://www.worldtaekwondo.org/wtf-partners/recognized/</u>)

- The Organizing Committee will provide Protector and Scoring System (PSS) to the participating contestants. Participating contestants are required to bring their own groin guards, mouthpieces, gloves, sensing socks and shin and forearm guards for their personal use.
- iv. Before entering the field of play, all contestants will proceed to the inspection desk for inspection of their doboks and protective equipment. <u>Any contestant who wears unofficial doboks or protective equipment will not be permitted to compete.</u>
- v. Instant Video Replay (IVR) System will be used.
- vi. Wireless communication system between referee and review jury will be used from Semi-Final.

19. IDENTIFIATION OF NOC CODE AND MANUFACTURER

- i. National flag shall be located between 3cm and 3.4cm below the right shoulder line of upper garment.
- ii. NOC Code is a three-letter National Olympic Committee abbreviation, and it shall be printed at the back in black and centred at 5cm or higher from the bottom line of the upper garment within the size of 30cm width x 12cm height. The font of the letters shall be in bold "Verdana".
- iii. Manufacturer's identification (name, designation trademark, logo or any distinctive sign of the manufacturer) shall be located one per garment within 20cm² except at the location of the WT or WTF logo.

20. MEDICAL CONTROL

- i. The WT Anti-Doping Rules, and where necessary the Code of the World Anti-Doping Agency, shall apply throughout the competitions.
- ii. Compulsory anti-doping tests will be carried out on random selection basis. The WTF and/or WADA may carry out random out-of-competition testing prior to the competition. Therefore, all participating contestants are required to submit their latest and most accurate Athlete Location (Whereabouts Info) Forms to the WT.
- iii. TUE (Therapeutic Use Exemption)

Athletes who take any substance or medicine listed in the "Prohibited List" of the WTF Anti-Doping Rules and Anti-Doping Code of World Anti-Doping Agency (WADA) for therapeutic purposes are requested to visit the website of WADA and make online filing of their TUE applications on ADAMS <u>http://www.wadaama.org/en/ADAMS/</u> and report to the WTF Sports Department at <u>marcoienna@wtf.org by no later than</u> <u>November 18th, 2017</u>. 21. HEAD OF TEAM MEETING & DRAWING OF LOTS SESSION

i. The head of team meeting and the drawing of lots session shall be conducted two (2) days prior to the start of the competition that is November 30th, 2017, in the presence of the WT officials and the representatives of the participating nations.

22. WEIGH-IN

- i. Weigh-in of the contestants shall take place on the day before their respective weight category.
- ii. During the weigh-in, male contestants shall wear underpants and female contestants shall wear underpants and brassieres. However, contestants may weigh-in in the nude if they wish to do so.

23. INDEMNITIES

- i. The respective national taekwondo associations shall be responsible for ensuring that all officials and participants are covered with effective travel & medical insurance coverage.
- ii. Participants without proper insurance coverage will not be allowed to compete at the competition.
- iii. The Organizing Committee will acquire general Public Liability event insurance.

24. ACCOMMODATION & TRANSPORTATION

OC will send it out separate invitation packet shortly.





25. VISA INFORMATION

The Organising Committee can provide recommendation letters for visa applications.

However, MNA's are required to check the Cote d'Ivoire entry visa application waiting times in their own countries and submit requests for recommendation letters to the organising committee.

The Organising Committee cannot guarantee entry into Cote d'Ivoire and can only offer assistance. It is the responsibility of each athlete and MNA to apply for and secure the correct entry visa for Cote d'Ivoire. MNA's are requested to complete the attached visa application recommendation form at least one week before the waiting time deadline in their own country.

26. COACH's ATTIRE

All Coaches are required to wear formal suit such as tie, jacket, dress shirt (long or short), and trouser during all matches. If any coach refuses to wear abovementioned attire, he or she won't be coaching for Abidjan 2017 GP Final as well as next GP Series.

27. TEAM DOCTOR'S MEETING

In order to receive accreditation card, all registered team doctors or physicians must attend team doctor's meeting on November 30th.

28. World Taekwondo Gala Awards 2017

On the evening of December 4th, WT Gala Awards 2017 will be held, and all GP final athletes and coaches required to attend.(Mandatory). During Gala Awards, Player of the Year (Male / Female), Coach of the Year, Referee of the Year (Male / Female), and MNA of the Year will be announced and awarded with prizes. All attendees are required to wear suit and dress, and recommended color code is black and white.
