16. CLASSIFICATION SCREENING

In the case that you are uncertain if your athlete will meet the Minimal Impairment Criteria (MIC) for participation in the K40 Sport Classes please find attached Classification Screening Form. Fill out the form and send it back to the WTF at para-tkd@wtf.org along with photos of the athlete's impairment and relevant medical documentation.

The information will be passed on to the WTF Classification Committee and you will be provided an answer to if your athlete meets MIC or not.

The Classification Screening process can take up to one (1) month. Accordingly, please submit your documentation in a timely manner.

Please be advised that Classification Screening does not replace classification and that the athlete will still have to go through classification at the championships.

17. DURATION OF CONTEST

All Para Taekwondo competitions will be held in accordance with the most up to date WTF Para Taekwondo Competition Rules.

Competitions will be held over three (3) rounds of two (2) minutes. Slight adjustments to the round length might be made for the K41 Sport Class.

19. CONSOLIDATION OF SPORT CLASSES

In the case of insufficient number of athletes participating in a sport class consolidation of classes shall be made as follows:

K41 → K42 K42 → K43 K43 → K44

An athlete that is consolidated into a higher Sport Class will be given the gold medal and Para Taekwondo World Ranking points as the winner of his/her sport class. The athlete will then have to compete for additional medals and ranking points in the higher Sport Class.

20. WEIGH-IN

Athletes will weigh-in the day before they are scheduled to compete. Weigh-in will be open as follows:

In accordance with the WTF Para Taekwondo Competition Rules Article 10.5 "When a contestant does not meet the weight during the official weigh-in for the weight division they registered in for the tournament or championships the contestant shall be disqualified."

23. TEAM STANDINGS

All medals over all sport will be counted towards the overall medal standing per country.

24. ATHLETE REPLACEMENT

Nations can replace any competitor for the Para Taekwondo competitions regardless of Sport Class and weight division for an athlete has been withdrawn for whatever reason up to two

weeks 16th November 2017 before the start of the IWAS World Games.

No entry fees will be retuned following the close of registrations on October 2, 2017

25. CONDITIONS OF PARTICIPATION

- 1) Round trip airfare and accommodation: Round trip airfare and accommodation charges of room and board shall be borne by the participating Member National Association.
- 2) Entry fees shall be paid in full for all athletes and officials participating in the 2017 IWAS World Games
- 3) Ground Transportation: Ground transportation will be provided for all athletes and officials that have chosen to pay the Inclusive Day Rates.

26. WTF RECOGNIZED EQUIPMENT

- 1) Participating contestants are required to wear WTF-recognized doboks* and WTF-recognized protective equipment. The latest version of WTF-recognized manufacturers' list is available at the website of WTF
- 2) http://www.worldtaekwondofederation.net/recognized
- 3) The Organizing Committee will provide head protector and Protector and Scoring System (PSS) to the participating contestants. Participating contestants are required to bring their own groin guards, mouthpieces, gloves, sensing socks and shin and forearm guards for their personal use.
- 4) Before entering the field of play, all contestants will proceed to the inspection desk for inspection of their doboks and protective equipment. Any contestant who wears unofficial doboks or protective equipment will not be permitted to compete.

*Note that article 4.2.4 of the WTF Para Taekwondo Competition Rules will be in effect

4.2.4 The Taekwondo uniform (dobok) sleeves for the K40 classes shall be cut and sown or rolled up not to provide additional coverage of sensors, restrict the movement of the athlete nor have a negative effect on the aesthetic presentation of the sport.

27. ANTI-DOPING

- 1) The IWAS Anti-Doping Code, and where necessary the Code of the World Anti-Doping Agency, shall apply throughout the competitions.
- Random anti-doping tests will be carried out during the competitions. The WTF and/or WADA may carry out random out of competition testing prior to the championships.
- 3) TUE (Therapeutic Use Exemption)
 Athletes who take any substance or medicine listed in the "Prohibited List" of the WTF Anti-Doping Rules and Anti-Doping Code of World Anti-Doping Agency (WADA) are requested to visit the website of WADA and make online filing of their TUE applications on ADAMS http://www.wada-ama.org/en/ADAMS/ and report to the WTF Sports Division at marcoienna@wtf.org by no later than November 1, 2017. Requests for visa invitation letters should be managed when submitting your final entries on the IWAS Management System.

Visa invitation letters will not be issued until Registration Fees are received in full.

TECHNICAL MEETINGS

Sport Technical meetings will be held the day before competition begins or as appropriate. The time and location of this meeting will be available upon arrival. Only sport specific matters can be raised and resolved in this meeting. The Team Manager Meetings can deal with the issues unrelated to sport.

TEAM MANAGER MEETINGS

Team Manager Meetings will address any issues excluding sport, for example, accommodation, transport and issues relating to finance. The first Team Manager's Meeting on arrival day will allow teams to confirm their flag and anthem for medal presentations.

ACCREDITATIONS

A recent passport sized photo, with a clear, light coloured background must be uploaded to the entry system for every member of the delegation. Accreditations will be available upon arrival to the Games.

ATHLETE LICENSING

IPC Licensed athletes must have a valid, current, IPC Review or Confirmed International Classification to be eligible to have their results recognised by IPC, for purposes of rankings, records and qualification for future events, prior to the start of competition. Please note, this is **not a requirement** for entry into the Games – only for athletes requiring recognition of results from IPC.

All athletes competing in Para Taekwondo must be licensed with the WTF ahead of entering the Games.

ANTI-DOPING

The IWAS Anti-Doping Code, a signatory of the World Anti-Doping Agency (WADA) Code, will apply to all sports. Athletes can be tested at any time, during or out of competition. For more information on the IWAS Anti-Doping Code, please visit the IWAS website.
