1. XVIII Mediterranean Games Tarragona 2018

The Mediterranean Games are a sport competition organised every four years, for the athletes of the National Olympic Committees (NOCs) of the Mediterranean countries members of the International Committee for the Mediterranean Games (ICMG). It is both a sport competition and a crossroad for the cultures, continents and people of the Mediterranean basin.

The Mediterranean Games are placed under the aegis of the International Olympic Committee.



2. Tarragona and the co-host cities

The 2018 Mediterranean Games will take place in Tarragona and in 15 other cohost municipalities, two of which are in the province of Barcelona (Barcelona and Casteldefells).

The 13 municipalities of the Tarragona surrounding area are: Altafulla, Cambrils, Calafell, Constantí, El Morell, El Vendrell, La Pobla de Mafumet, La Selva del Camp, Reus, Salou, Torredembarra, Valls and Vila-seca.

Tarragona lies in Southern Catalonia and it is the capital of the Tarragona district and of its province. Founded in the 3rd century bC, it has a large port and it is the heart of a vast petrochemical centre. It was the capital city of the Roman province Hispania Citerior and it still retains important archaeological remains of that period.

Tarragona is a city of light and colours. Its climate, gentle and Mediterranean, toge-

ther with the welcoming ambiance of its streets and the hospitality of its inhabitants, helps create the large, fun, festive and cultural space in the open air that it has become.

On the shores of the Mediterranean Sea, Tarragona is one of the four capitals of the region of Catalonia; it is located 92 km South of Barcelona. The city spreads along 14 km of the littoral and its beaches have fine and golden sand, hence its name of Golden Coast (Costa Daurada).

Tarragona is a worthy heir of the Imperial Tarraco. It is a unique city that has succeeded in combining its remarkable Roman and medieval heritage with true modern gems: all serves to make it a prime tourist destination.

The city has always sought to recognise and respect its Roman heritage. This has led to the inscription of the archaeological ensemble of Tarraco, which lays in the city, to the UNESCO's World Heritage, in 2000.




3. Climate

Tarragona enjoys a real Mediterranean climate, with mild temperatures during winter, and warm, dry summers.

The yearly average temperature is slightly over 16°C and rainfalls are inferior to 500mm.

It only rains between 2 to 4 days in June and July, with an average temperature of 24°C.



10. Overview of Accreditation

This manual, prepared by the Organising Committee (OCMG) following the Accreditation Table contained in the International Committee for the Mediterranean Games (ICMG)'s Protocol Manual, has been approved by the ICMG, in order to assist participating NOCs and other client groups to prepare for the Accreditation and Sports Entry (only for NOCs) process for the XVIII Mediterranean Games – Tarragona 2018 (the Games/MG).

The ICMG determines the categories entitled to hold an Accreditation card and the conditions, entitlements, privileges, seating stands, access to ceremonies and quotas for issuing the cards to participants according to their roles and retains the right to grant or refuse accreditation for access to the Games venues.

All the privileges that the ICMG in accordance with the OCMG have agreed for the XVIII Mediterranean Games Tarragona 2018 will be found in the Accreditation Chart attached to this document. Each Category will be provided with that Chart as a reference for all of their privileges.

The purpose of accreditation is to identify and register all persons involved in the Games and to grant them the necessary privileges to perform their tasks. Accreditations do not replace visas required to enter on the national territory.

The OCMG has established in conjunction with the ICMG the accreditation deadlines for each of the ROs. Each RO will need to name a responsible Accreditation Liaison Officer (ALO) who will be the main point of contact with the OCMG for Accreditation related matters.

The OCMG will provide accreditation cards, upon presentation of a valid ID and/or passport – depending on the visa requirements for the country of origin – to all participants who have submitted full applications in due time, passed any relevant security controls and have met the criteria set by the ICMG.

The necessary ID and/or Passports will need to be valid at least until 1 month after the Games Closing Ceremony (01/08/2018).

The Accreditation card will be the only valid ID during the Games, which can be used as a pass and access to the various venues during the Games and which will identify the privileges granted to the accredited person.

Applications for an Accreditation Card may only be received from an approved RO via their ALO. No applications from individuals for accreditation may be submitted. Approved ROs are the ones recognized by the ICMG.

The Accreditation categories approved by the ICMG, according to the official Accreditation chart, are:

- The ICMG
- The IOC
- The NOCs
- The IFs
- The OCMG
- Media covering the Games: Broadcasters/Radio (ERT), Journalists (E), Photographers (EP).

The responsibility of accrediting all of the above categories by their ALOs is as follows:

All information submitted as part of the accreditation application must be accurate. ROs are strongly recommended to ensure that all information is correct, particularly the spelling of names, identity document numbers and dates of birth.

ROs are officially recognised by the OCMG as participants, responsible for performing several tasks associated with the deployment of their delegation. It is only ROs approved by the OCMG that are eligible to request accreditation for their accredited persons. ROs are responsible for managing the accreditation process for any third parties or sub-contractors required by them to participate in the Games. ROs must appoint a designated point of contact (ALO), responsible for managing the accreditation administration. ROs should comply with any existing legislation concerned when collecting personal data from their accredited persons, including where relevant permission to pass this information to the ICMG might be needed.

12. The Accreditation Card

The accreditation card should be worn by all participants to access accredited venues at Games time. The elements printed on the card will be large enough to allow security/access control staff to quickly ascertain if a participant is authorised to enter the venue and specific zones within the venue. The card usually contains a number of security features protecting counterfeit/fraudulent activity.

The details on the card will be printed in French and English.

The front of the accreditation card will contain:

- A recent (within 12 months) colour image of the card bearer;
- The name of the card bearer;
- The Games logo;
- A large category code, with the corresponding background colour as determined in the Accreditation chart;
- The Games time role that the card bearer holds;
- Transport privileges (where applicable);
- Codes determining the venue access permitted;
- Codes determining the areas within the venue an individual is permitted to access;
- Seating privileges (where applicable);
- A visible security feature;
- The unique reference number for the accredited person.

The back of the accreditation card will contain:

- A recent (within 12 months) colour image of the card bearer;

- The official name of the card bearer as detailed on their identity document;
- Sponsor recognition (if applicable).
- Official ICMG text, in French and English, as follows:

"This Mediterranean Games Identity and Accreditation Card remains the property of the International Committee of the Mediterranean Games (ICMG) and can be withdrawn. with immediate effect, at the ICMG's sole discretion. By using this Card, the holder agrees to be filmed, televised, photographed, identified and otherwise recorded during the XVIII Mediterranean Games- Tarragona 2018under the conditions and for the purposes now or hereafter authorised by the ICMG and/or OCMG in relation to the promotion of the Mediterranean Games and the Olympic Movement. The holder agrees that all photographs and moving images taken by the holder at the Mediterranean Games, including those of athletes competing within any Mediterranean Games venues, shall be used solely for personal and non-commercial purposes, unless the prior written consent is obtained from the ICMG and/or OCMG. The holder also confirms that they fulfil the qualifications and conditions required by the ICMG and/or OCMG in order to be issued this Accreditation Card

The holder also agrees to authorize the use of any information about him/her collected by the ICMG and OCMG and to such data being processed, stored and used by them, and, where necessary, third parties, for the purposes of facilitating their participation in, and/or organising, the Mediterranean Games.

(Please note that the E-Accreditation Portal and therefore the design of the cards are not final)





When an application is submitted or saved in the E-Accreditation Portal the users will also need to attach a digital photo of the applicant to the record.

Accreditation cards cannot be produced without an approved photo that meets the following specifications. Not providing an appropriate photo through the E-Accreditation Portal will delay the validation and/or first access of any participant to an accredited venue.

Kindly take note of the digital photo requirements:

- Be the only person in the photo;
- Face forward, looking straight into the camera with eyes open and nothing covering the face;

- Looking natural with no facial expressions, for example grinning or frowning;
- Nothing covering the eyes, for example, hair or glasses frames;
- No sunglasses or tinted glasses;
- No hat or anything covering the head unless for medical or religious reasons;
- In colour, not black and white;
- Be taken against a white or light cream background.

Photograph format:

- Digital image file (jpeg, jpg, png, gif or bmp);
- 100-400kB size;
- Passport style photograph (width-to-height ratio 4x5).



Further details and requirements on the Accreditation process, and more specifically on the data collection via the E- Accreditation Portal, will be provided to the various categories once the System is be ready for usage through a "E- Accreditation Users Guide".

13. Categories, Functions and Quotas

All applications for accreditation are determined by their category and function. The function is the role of the individual entitled to hold an accreditation card. The access entitlements for these categories and functions are defined in the Accreditation Chart in annex.

The categories and quotas of accreditation cards per function are determined by the ICMG, according to the ICMG Accreditation Chart.

An individual with *multiple functions* may only hold one Accreditation Card for the period of the Games. Approval from the ICMG, via the OCMG, will be required to merge accreditation privileges for any exceptional circumstances, where an individual is required to perform multiple functions.

Substitutions are NOT permitted in the XVIII Mediterranean Games Tarragona 2018.

Rotations are only permitted twice for the transferable guest under the NOC Category.



14. Accreditation Process and key dates per category

The E-Accreditation Portal will be accessed by each RO with their own log-in details via the Games Official Site. The site will be accessible in French and English exclusively through the Games' site: www.tarragona2018.cat.

The different phases of the General Accreditation Process are the following:

1. Before the opening of the E-Accreditation Portal

OCMG will provide ORs with the following documentation:

- E-Accreditation Portal Users Guide;
- Users Account Form to have individual access to the System;
- An updated Accreditation Manual (if changes have occurred);
- Any other relevant access information.

2. Opening of the E-Accreditation Portal

The System will be opened to the ORs from **15 February 2018.**

ORs are allowed from this moment onwards to enter information on the number of participants in each event to which they plan to take part.

3. Deadlines for entries other than NOC Delegations

- Media representatives (journalist and photographers, categories E & EP) can be accredited by the NOCs of their respective countries until 6 April 2018, by 23:59, Spanish time. The RO is each NOC for the media representatives from its country.
- All accreditations belonging to the International Federation categories (see Accreditation Chart in attachment) except President and Secretary General can be entered until 6 April 2018, by 23:59, Spanish time, through the Sports Department of the OCMG.
- TV teams under the **ERT** category must be accredited until **6 April 2018**, **by 23:59, Spanish time**, exclusively through the OCMG.
- The following **VIP** et local persons (according to the ICMG Accreditation Chart) can be entered by the indicated RO until **11 May 2018, by 23:59 Spanish time**:

• All **ICMG** and **IOC** categories. The RO is the ICMG.

• **NOC** and **NOC**** categories of the National Olympic Committees chart. Each NOC is the RO for its respective persons.

• The **IF Presidents** and **Secretaries General**. The RO is the OCMG International Relations & Protocol Department. • For all categories of the OCMG chart, the RO is the OCMG.



15. Accreditation and Entry Process for NOC Delegations

NOCs are one of the largest categories in the XVIII Mediterranean Games since this category is open to a great number of people, including basically athletes and officials.

Despite the fact that the E-Accreditation Portal will be used by all participating categories to enter their Data, the NOCs will merge the Accreditation Process for their athletes with their Entries Process through the E-Accreditation Portal. That is the reason why it is considered extremely necessary to specify the Delegations Accreditation and Entries process in this document.

NOCs will be provided before the opening of the E-Accreditation Portal with the appropriate "Games Calculator Rule" in order to obtain the final number of their Officials depending on the number of participating Athletes.

The Calculator will be provided to NOCs for a perfect understanding of the process.

The E-Accreditation Portal will be accessed by each participating NOC with their own log-in details via the Games Official Site, which will be accessed in French and English, exclusively through the site: www.tarragona2018.cat.

The different phases of the NOC Accreditation Process are as follows:

15.1. Before the opening of the E-Accreditation Portal

OCMG will provide NOCs with the following documentation:

- E-Accreditation Portal Users Guide;
- Users Account Form to have individual access to the System;
- An updated Accreditation Manual (if changes have occurred);
- Any other relevant access information.

15.2. Opening of the E-Accreditation Portal:

The System will be opened to the NOCs from **15 February 2018.**

NOCs are allowed from this moment onwards to enter all information about all potential athletes and officials included in the NOC category, without a maximum number of persons.

All participating athletes must be citizens of the countries they represent according to the IOC rules.

Athletes must be entered in each event into which they could take part.

15.3. Entries by number:

The list of entries by number of an NOC with participating athletes must be sent to the OCMG, via the E-Accreditation Portal, until the **22 March 2018 (23:59, Spanish Time)** at the latest.



15.4. Entries by name (Long List):

Preliminary entries with the data of all the NOC athletes potentially participating at the Games will be sent via the E-Accreditation Portal to the OCMG at the latest on the **6 April 2018 (23:59, Spanish Time)**. Any potential participant must be assigned to all sport events (minimum one event) in which he/she might be finally entered.

The same deadline applies for NOC potential Officials. NOCs are requested to include in the long list any potential member of the official delegation (athletes and officials), with no limit of initial entries, as no athlete or official can be added after the deadline of 6 April 2018.

15.5. Final entries by name (Short List)

15 days before the beginning of the Games, on the **7 June 2018 (23:59, Spanish Time)** at the latest, NOCs must send their final entries list per name and per event through the E-Accreditation Portal, confirming from the initial Long List the names of the participating athletes already entered before 6 April 2018.

15.6. DRMs

Delegation Registration Meetings (DRM) are the one-to-one meetings between each NOC Chef de Mission and the OCMG, to confirm any eventual change in the short list. DRMs will be held in Tarragona during the **15 and 16 June 2018**. Further and extended details about the DRMs will be provided at the Chef de Mission Seminar. The Final NOC Accreditation and Entries List will be included in the DRM Report, which must be signed by the Chef the Mission at the end of the DRM.

An NOC Disclaimer Form will be provided to NOCs in due time for their own analysis. NOCs will need to return it signed to the OCMG during the DRM Meetings at the latest.

15.7. Exceptional changes after the DRM

Exceptional changes after the DRM in any of the athletes entries will be allowed only until two hours before the Technical Meeting of each sport and exclusively for medical reasons, according to the following Late Athlete Replacement (LAR) Process (included also in the Chefs de Mission Manual).

LATE ATHLETE REPLACEMENT POLICY AND PROCEDURE (LAR)

The deadline for confirmation of sport entries of participating athletes in the Mediterranean Games Tarragona 2018 (short list) is **7 June 2018 (23:59, Spanish time).**

However, where urgent medical problems arise, or in other exceptional circumstances that are assessed on a case-by-case basis, the ICMG may permit the permanent replacement of one athlete by another only in the same sport, discipline and event.

Replacement of an athlete can only occur after consultation with the relevant IF and, when deemed necessary by the ICMG, an ICMG medical expert.



The replacement of athletes due to medical reasons after 7 June 2018 and up to 2 hours prior to the Sport Technical Meeting is possible only provided that the following rules are respected:

- 1. The replacement athlete (substitute) has to be entitled to take part in the Games as stipulated in the ICMG rules;
- 2. No doping control issues concerning the substitute must be pending;
- 3. The name of the substitute has to be included in the NOC long list prior to the application for accreditation deadline on 6 April 2018;
- 4. Following the athlete replacement, the accreditation card of the replaced athlete shall be cancelled.

The following additional procedures must also be carried out in order for one athlete to be replaced by another:

- a) The relevant NOC must fill out an Official Athlete Replacement Form for the athlete to be replaced and the substitute;
- b) The relevant NOC must provide medical documents justifying the replacement.
- c) A new "Sport Entry Form" must be duly completed and submitted by the relevant NOC for the substitute.

Following confirmation from the OCMG Tarragona 2018 that the submission procedure has been correctly completed, the application for LAR shall be approved by:

- The Technical Delegate for the relevant sport or discipline, on behalf of the IF;
- The designated representative of the ICMG.

Any LAR request and necessary documentation should be sent by email or submitted in person to the OCMG Tarragona 2018 Sports Entries department, at:

LAR due to **exceptional circumstances or requested after the deadlines** are subject to the approval of the ICMG.

16. Special passes, Guest and Day Passes

16.1 The 2-part pass

This card is used for workers, to provide the OCMG operational flexibility to deploy workforce across a number of venues on a day-to-day basis whilst maintaining control of the total headcount on venue. This comprises a shortened version of the regular accreditation card (first part pass), containing the individual's personal information, and must be used with the upgrade card (or second part of the pass) to permit access to venues.

16.2. Guest Passes

Guest passes are produced for specific Games venues for non-accredited persons in venues such as the Village and other various Games Venues.

Mediterranean Village Guest Pass

The athletes are at the heart of the Games, and in order to ensure they have a secure and private environment to prepare themselves for competition, access to the village is strictly controlled.

The Mediterranean Village is a space mainly residential where only accredited persons with the right to do so have access. Accredited persons can access the operational area of the Village and/or the residential part of the Mediterranean Village with a Guest Pass, according to the following description.

There are three different types of Mediterranean Village Guest Pass:

- 1. NOC Mediterranean Village Guest Pass, which provides access to the operational areas of the Village and escorted access to the Residential Zone. Quotas for NOC Mediterranean Village Guest Passes are determined according to the delegation size.
- 2. Media Mediterranean Village Guest Pass, which provides access to the operational areas of the Village only. Quotas are determined by the ICMG.
- 3. **Protocol Mediterranean Village Guest Pass,** which provides access to the operational areas of the Village and escorted access to the Residential Zone. Mediterranean Games Family Operations manages this group.

These passes are created to strictly preserve the privacy of the Athletes. They are delivered on presentation and deposit of their Accreditation or Passport / ID Cards for a Daily Guest Pass to the Mediterranean Village.

Daily quotas are limited by the OCMG. It is the ROs responsibility to invite and register all guests in advance, including communicating any requirements set by the OCMG, such as presenting original identity documents.

Applications must be submitted in advance, at least the previous day by 15:00, at the Guest Passes Centre at the Mediterranean Village. All applicants are required to comply with any security requirements determined by the Host Country. ROs may only apply for Mediterranean Village Guests passes within their permitted quota. No guests will be permitted



to enter the Mediterranean Village in the event that an application is not submitted in advance.

The individual is required to visit the Guest Pass Centre, which is operated by the OCMG on the perimeter of the Mediterranean Village to collect the pass. They will be required to surrender their accreditation card or other official identity document, such as a passport or ID card.

Guest passes holders need to leave the Village by closing time and return their daily pass. In that moment, they will recover their exchanged Accreditation card or ID / Passport.

16.3 Other venues Guest Pass

The OCMG can determine guest passes to allow access to other competition or non-competition venues, if required by other ROs. The procedures will be established and communicated in due time.

16.4 Day Pass

A Day Pass is a venue specific temporary access pass, issued for operational reasons at competition or training venues only. Day passes are only valid for the day on which they are issued. In order to obtain a day pass, functional areas must provide full justification for the reason for access.

These passes are used for:

Repairs / Maintenance of equipment / Overlay / Structures within the venues or unforeseen emergencies / Temporary assignment from another venue to provide shift relief / Operational support / Personnel management of disputes / Performance issues.

Operational intervention as agreed with the Venue Manager

Should not be used for observation, general meetings with colleagues nor for inviting/escorting guests.

The procedures will be established and communicated in due time.

16.5 Access to Restricted Areas

Access to certain zones, sessions, areas and ceremonies may require in addition to the Accreditation Card other devices such as armbands, bibs or tickets. These are known as Supplementary Access Devices (SAD).

All SAD must be approved by the OCMG and registered with the relevant accreditation function;

SAD must be used along with the accreditation card as they do not grant the access to any venue or zones by themselves;



17. Accreditation Facilities and Accreditation Team

Accreditation Facilities services are provided to the various participants of the XVIII Mediterranean Games of Tarragona 2018.

The Accreditation Centres for the XVIII Mediterranean Games Tarragona 2018 will be the following:

- Main Accreditation Centre (MAC) at the Mediterranean Village: for athletes, team Officials, OCMG and the task-force.
- Accreditation Centre for the Mediterranean Family at the Main Mediterranean Games Family Hotel: for ICMG, IOC, IFs, NOCs, Dignitaries, and Other Guests.
- **Media Accreditation Centre:** this centre will be located at the Main Press Centre.

The opening hours of the three different Accreditation Centres will be:

- MAC at the Mediterranean Village: 24/24
- Accreditation Centre for the Mediterranean Family at the main Mediterranean Games Family Hotel: 09:00 to 19:00 (except early or late arrivals previously communicated).
- **Media Accreditation Centre**: 09:00 to 19:00 (except early or late arrivals previously communicated).

In case an accredited person loses the Accreditation Card, he or she will need to go to one of the above mentioned Accreditation Centres with a proper ID or Passport in order to get a duplicate of the card and fill in a "Lost Card Declaration" in order to be issued with a replacement.


