<p><b>QUALIFICATION SYSTEM</b></p>	<p>i. Any NOC who qualifies a minimum of two (2) male and two (2) female players via the Olympic ranking system will be deemed to have qualified its total quota of places and shall not be permitted to enter the continental qualification events. However, if a nation has not qualified a minimum of two (2) places in male and two (2) places in female via the Olympic Ranking position they shall be allowed to compete for the additional places via the continental qualification events.</p> <p>ii. The first ranked athletes in the weight categories will qualify their NOCs a place each for Olympic games. Total eight (8) athletes will qualify their NOCs a place each for Olympic games through Oceania Qualification Tournament.</p> <p>iii. The winner of the final within a weight division will qualify their NOCs. The 3rd place will be determined by the result of final matches.</p> <p>iv. If an NOC qualified through the Oceania Qualification Tournament relinquishes a quota place or has not confirmed the use of the qualified place(s) within two (2) weeks from the moment receiving the allocation letter from the WT, it will be reallocated to the NOC of the next highest ranked athlete in the same weight category at the Oceania Continental Qualification Tournament, as long as the NOC does not exceed the quota of two (2) male and two (2) female.</p> <p>v. In the event that any of the qualified contestants was found to have committed a doping offence that constitutes a violation of any of the provisions of the Anti-Doping Code of the World Anti-Doping Agency and/or other appropriate anti-doping codes ("Anti-Doping Codes"), next highest ranked athlete in the same weight category at the African Continental Qualification Tournament will qualify his/her NOC a place.</p> <p>vi. The NOC of an athlete who has committed an anti-doping rules violation will lose the quota place obtained by the athlete. The maximum number of quota places for that the corresponding number of athletes who committed an offence shall reduce NOC.</p>
<p><b>AWARDS</b></p>	<p>Medals will be awarded to the top four athletes in the respective weight category of the pertinent championships:</p> <p>1<sup>st</sup> place – gold medal and certificate  2<sup>nd</sup> place – silver medal and certificate  3<sup>rd</sup> place – bronze medal and certificate  3<sup>rd</sup> place – bronze medal and certificate</p>
<p><b>COACHES ACCREDITATIONS AND QUALIFICATIONS</b></p>	<p>The minimum qualification requirements for coaches are as follows:</p> <p>All coaches must be at least 18 years of age.</p> <p>All Coaches / Trainers must be holders of WTO License (granted by participation in a WTO Coach License Seminar</p> <p>Coaches / Trainers that do not have the WTO Coach License shall pay a \$ 200.00 USD fine at the registration desk before any coaching accreditation can be issued.</p>

<p><b>DRESS CODE</b></p>	<p>During the preliminary rounds, coaches shall wear either a neat tracksuit or a shirt, pants and suit jacket.</p> <p>Please note that for semi-finals and finals it is a WT requirement that coaches wear a suit jacket.</p> <p>During the Head of Team meeting, further information about dress code shall be provided to the teams.</p>
<p><b>PROTECTOR &amp; SCORING SYSTEM (PSS)</b></p>	<p>DAEDO Gen. 2 is being used as the PSS. The Organising Committee will provide DAEDO trunk protector and DAEDO headgear.</p> <p>The PSS and hit-levels to be used at these Oceania Qualification Tournament for the Games of the XXXII Olympiad will be equivalent to those to be used at the TOKYO 2020 Games.</p> <p><u><b>IMPORTANT NOTE: Athletes must supply their own DAEDO sensor socks.</b></u></p>
<p><b>RECOGNISED BRANDS</b></p>	<p>Participating contestants are required to wear WT- recognised doboks and WT-recognized protective equipment. <p><b>IDENTIFIATION OF NOC CODE AND MANUFACTURER</b></p>	<p>National flag shall be located between 3cm and 3.4cm below the right shoulder line of upper garment.</p> <p>NOC Code is a three-letter National Olympic Committee abbreviation, and it shall be printed at the back in black and centred at 5cm or higher from the bottom line of the upper garment within the size of 30cm width x 12cm height. The font of the letters shall be in bold “Verdana”.</p> <p>Manufacturer’s identification (name, designation trademark, logo or any distinctive sign of the manufacturer) shall be located one per garment within 20CM except at the location of the WT logo.</p>
<p><b>MEDICAL CONTROL</b></p>	<p>i. The WT Anti-Doping Rules, and where necessary the Code of the World Anti-Doping Agency, shall apply throughout the competitions.</p> <p>ii. Compulsory anti-doping tests will be carried out on random selection basis. <b>CONDITIONS OF PARTICIPATION</b>	<p>Round trip airfare and accommodation: Round trip airfare and accommodation will need to be organised by Member National Association with costs being borne by the participating Member National Association.</p> <p>Ground transportation: ground transportation to and from the airport, as well as transportation from the accommodation to the competition venue shall be borne by the participating Member National Association.</p>
<b>HEAD OF TEAM MEETING &amp; DRAWING OF LOTS</b>	<p>The Head of Team meeting shall be conducted by WTO officials on 28 February 2019. Exact location and time shall be communicated forthwith.</p>
<b>WEIGH-IN</b>	<p>Weigh-in of the athletes takes place the day prior to the start of the respective weight category they compete in. <b>COUNTRY ENTRY VISA</b>	<p>A Visa to enter Australia may be necessary.</p> <p>The visa recommendation letters will be automatically generated from WT GMS platform if the visa requested during the registration for the event. All the members who need entry visa to Australia must be registered in GMS.
