license. Onsite registration for WT license is not possible. WT ranking points can only be awarded to those athletes with a valid WT license.

Those who are not recognized as adults by law in their own country must submit a passport or identification card together with a written consent (liability declaration) of their parents or lawful guardian accepting the participation and all parts of the official invitation.

#### Visa

In order to give support to get the visas it is necessary to send a correct written application letter to the Austrian Taekwondo Federation, with the names, age and passport-No. of all team members, competitors and officials (if possible, please send a word file as e-mail attachment). We will send an invitation letter by air mail to the team and to the Austrian Embassy in your home country.

Please give the visa process in the embassies at least two weeks for handling all applications.

Before weigh-in all coaches must have the Special ID-Cards for their teams. Weigh-in and entry to the sports hall only with Special ID-Cards. Special ID-Cards for all competitors and coaches!
