Entry and Exit Requirements:

Published 25.11.2021

1. Passengers entering or transiting through Albania must have:

- a COVID-19 vaccination certificate showing that they were fully vaccinated at least two weeks before arrival; or

As a **bio-secured bubble format** will apply at this event all participants (athletes, coaches, trainers, officials, referees, staff, etc.) will be tested with a Rapid Ag Test (paid on-spot) at the entrance of the "Bio-secure bubble" and will be allowed to enter the event premises only if the result is negative. Participants that are tested positive will not be allowed access and, in this case, Local Authorities' health protocols will be followed.

COMPETITION RULES

WT Competition Rules & Interpretation, in force as of October, 2020.

COMPETITION SYSTEM

Single elimination tournament system.

CONTEST TIME

Senior divisions : 3 rounds of 2 minutes, 1-minute break between each round

The WT Technical Delegate has the authority to adjust the contest time as he sees fit.

GENERAL ELIGIBILITY REQUIREMENTS

Each team/club can send as many athletes as they wish per weight category to compete in the 7th WT President's Cup | European Edition 2022 weight divisions.

ELIGIBILITY REQUIREMENTS

1. Holder of a valid 2022 WT Global Athlete License;
2. Member of the team/club of a pertinent Member National Association, recognized by European Taekwondo Union or World Taekwondo;
3. Holder of:
 - Seniors : a national or Kukkiwon Dan certificate
4. An athlete in order to be eligible for participation must be born in 2005 or before

All competitors must prove their age by presenting their passport or identification card at the official weigh-in. For those athletes that are not adults, a written consent must be submitted (please find enclosed on the last pages) at the registration, signed by one of the parents or legal guardians, accepting their participation and all parts of the official invitation.

COACH ELIGIBILITY REQUIREMENTS

1. Minimum age of 18 years;
2. WT Coach Certificate Level I or above is required;
3. Holder of a valid 2022 WT Global Official License;
4. Coach is not allowed wearing Dobok.
5. 1 coach per 5 athletes is allowed. Exceeding this ratio is subject to an extra fee.

PROOF OF PAYMENT REQUIREMENT

Athlete sport entries may be deleted if no payment has been received. Each team shall inform ETU of their entry fee payment by submitting the transfer slip before the registration and payment deadline at cutt.ly/submitpayment

Athletes that are registered and not participating shall be deleted from the system BEFORE the registration deadline. If they are not deleted from the system they are considered as participating athletes and their entry fee shall be paid in full, even if they do not show up at the event.

INDEMNITIES

It is the responsibility of each registering team to ensure that their athletes and team officials have filled out the indemnification forms correctly and have duly signed them, thereby indemnifying WT, ETU, the Organizing Committee and all other officials and athletes from any claims of injuries, losses or otherwise arising in the course of participation at the 7th WT President's Cup 2022 | European Edition or any activities linked therewith.

It is the responsibility of each registered team to ensure and guarantee that sufficient insurance coverage has been arranged for all athletes, team officials and other participants. Without sufficient insurance coverage, teams will not be allowed to compete.

Please fill out the Personal Indemnity Forms and return them to the Organization Committee before the deadline. Each participant (athletes, team officials, etc.) has to fill out the indemnification form.

MEDICAL INSURANCE

All participating athletes, coaches, team officials, technical officials and participants at ETU events shall have mandatorily an international medical insurance that covers medical care(COVID included) and in case of emergency, repatriation to the country of origin, valid on the days present in the host country of the event. ETU nor the Organizing Committee shall be responsible to cover any medical costs incurred for medical treatment before, on or during the competition or repatriation in the broadest sense of the word.

All relevant documents proving that such an insurance is present, including insurance policy papers, should be taken to the event in case a medical situation occurs.

Cadet divisions : 3 rounds of 1,5 minutes, 1-minute break between each round

The WT Technical Delegate has the authority to adjust the contest time as he sees fit.

GENERAL ELIGIBILITY REQUIREMENTS

Each team/club can send as many athletes as they wish per weight category to compete in the 7th WT President's Cup | European Edition 2022 weight divisions.

ELIGIBILITY REQUIREMENTS

1. Holder of a valid 2022 WT Global Athlete License;
2. Member of the team/club of a pertinent Member National Association, recognized by European Taekwondo Union or World Taekwondo;
3. Holder of:
 - Juniors : 1st Kup and above
 - Cadets : 1st Kup and above
4. An athlete in order to be eligible for participation must be born in:
 - Juniors : 2005, 2006 or 2007
 - Cadets : 2008, 2009 or 2010

All competitors must prove their age by presenting their passport or identification card at the official weigh-in. 1. Only quarter finalists are eligible for quota places.
2. *For the Cadet weight divisions:* The **top 2** athletes - with a **maximum** of **one** athlete per MNA per qualification event - qualify directly for the respective events.

EXPLANATION:

- a. *In case the top 2 are from the same nationality, the bronze medalist who lost from the gold medalist takes the quota.*
- b. *In case this bronze medalist is of the same nationality of the gold medalist, the quota goes to the bronze medalist who lost from the silver medalist.*

c. In case this bronze medalist is of the same nationality of the gold medalist, the quota goes to the athlete who lost in the quarter final from the gold medalist.

3. For the Junior weight divisions: The **top 4** athletes - with a **maximum of two** athletes per MNA per qualification event - qualify directly for the respective events.

EXPLANATION:

a. In case the top 4 are from the same nationality, the remaining two quotas are awarded to the athletes that lost in quarter final from the gold and silver medalist.

b. In case the top 3 are from the same nationality, the remaining one quota is awarded to the athlete that lost in quarter final from the gold or silver medalist.

c. In any other case regarding rule 3, the quota(s) are awarded to those athletes that lost in the quarter finals from the gold, silver or bronze medalist.

4. Quota places obtained in non-Olympic weight divisions get combined for Olympic weight division events.

MEDICAL AND ANTI-DOPING

Applicable medical rules

The WT Medical Code, WT mouthguard, bracing, taping, padding and piercing rules are applicable, which all MNA participating this event must comply.

Applicable doping rules

The WT Anti-Doping Rules and the WADA Anti-Doping Code are applicable. Compulsory random doping tests will be conducted among the all athletes. World Taekwondo and/or WADA may carry out random out-of-competition testing prior to the event.

Therapeutic Use Exemption

INDEMNITIES

It is the responsibility of each registering team to ensure that their athletes and team officials have filled out the indemnification forms correctly and have duly signed them, thereby indemnifying WT, ETU, the Organizing Committee and all other officials and athletes from any claims of injuries, losses or otherwise arising in the course of participation at the 7th WT President's Cup 2022 | European Edition or any activities linked therewith.

It is the responsibility of each registered team to ensure and guarantee that sufficient insurance coverage has been arranged for all athletes, team officials and other participants. Without sufficient insurance coverage, teams will not be allowed to compete.

Please fill out the Personal Indemnity Forms and return them to the Organization Committee before the deadline. Each participant (athletes, team officials, etc.) has to fill out the indemnification form.

MEDICAL INSURANCE

All participating athletes, coaches, team officials, technical officials and participants at ETU events shall have mandatorily an international medical insurance that covers medical care(COVID included) and in case of emergency, repatriation to the country of origin, valid on the days present in the host country of the event. ETU nor the Organizing Committee shall be responsible to cover any medical costs incurred for medical treatment before, on or during the competition or repatriation in the broadest sense of the word.

All relevant documents proving that such an insurance is present, including insurance policy papers, should be taken to the event in case a medical situation occurs.

Each MNA/Club, Team doctor or team medical staff must ensure their athletes and team officials have valid international health insurance that covers medical and emergency care at the designated hospitals in Albania before arrival to the venue.

COVID-19 TESTING

In case a team representative or official needs to be COVID tested at any time during the competition or before departure, the OC could arrange the tests within 72 hours' notice.
