

The competition will award ranking points in accordance with World Para Taekwondo Ranking By Law Article 5.6.

Athletes from Europe will receive G4 ranking points, athletes from other continental federations will receive G2 ranking points.

Article 6.4 of the World Para Taekwondo Competition Rules states that all international Para Taekwondo competitions recognized by WT shall be formed with participation of no less than three (3) countries. Official results from Para Taekwondo competitions with less than three (3) countries participating shall not be recognized by WT. Any sport class and weight category with less than three (3) athletes from two (2) countries shall not be recognized in the official results.

## 7. Accommodation and Transport

### 7.1 Accommodation Booking

All accredited people attending the event shall mandatorily book their hotel accommodation via the Organising Committee. Any athlete or team members that do not comply with this regulation shall pay an increased entry fee by 100 EUR on top of the regular fees before receiving an accreditation card.

All accommodation requests must be submitted using the Accommodation and Meals Booking Form.

50% deposit is required at the time of booking.  
Full balance is due by Friday 15 April.

### 7.2 Official Event Hotels

Four Official Event Hotels will be used during the European Championships. All hotels offer accommodation in high quality single, twin and double rooms. All accommodation rates include:

### 7.3 Transport

The Organising Committee will provide transport between Manchester Airport and the Official Event Hotels for arrival and departure of accredited event attendees staying in Official Event Hotels. Travel to any other port of entry or exit is the responsibility of the team or individual.

The Organising Committee will provide transport between the Official Event Hotels and the competition and training venue for accredited event attendees staying in Official Event Hotels. The training venue is located on the Etihad Campus alongside the competition venue and will use the same transport service. Travel to any other hotels or venue is the responsibility of the team or individual.

Registered teams only receive the athlete and official's accreditation cards if all financial obligations have been fulfilled. For all registered athletes, the entry fee has to be paid before the accreditation cards will be distributed to the respective team.

Persons accredited as 'Trainer' do **not** have access into the Field of Play.

### 9.3 Registration Deadline

**18 April 2022, 23:59 CET**

This deadline applies for all sport entries, payments and submitting all required documents.

### 9.4 Fees

#### 9.4.1 Standard Entry Fees

Fees paid between 08 March and 2359 on 08 April will be **125 EUR per registered athlete**

#### 9.4.2 Late Entry Fees

Fees paid between 09 April and 2359 on 18 April will be **150 EUR per registered athlete**

#### 9.4.3 On-site Change of Medal Event (Weight Division)

Medal events (weight divisions) cannot be changed after the entry deadline of 23:59 CET on 18 April 2022.

#### 9.4.4 Additional Accreditation Cards

**50 EUR** for each on-site approved additional requested accreditation card or additional officials' accreditation card on top of the quotes in Section 7.2

#### 9.4.5 Protest Fee

In case of an official protest submitted according to WT Rules a non-refundable **200 EUR** fee shall be paid.

#### 9.4.6 Replacement of athletes

In case an athlete needs to be replaced after the deadline this can be done maximum of 48 hours before the draw will take place. A fee of **175 EUR** is applicable. Replacement athletes must be present at the event and meet all applicable entry and eligibility criteria.

### 9.5 Payment Method

All entry fees shall be paid in advance to the Organising Committee. Cash payments will not be accepted.

## 9.6 Proof of Payment

Athlete sport entries may be deleted if full payment has not been received. Each team shall inform the ETU of their entry fee payment by emailing the transfer slip before the registration and payment deadline to [taekwondo@cseplc.com](mailto:taekwondo@cseplc.com)

Athlete that are registered and not participating must be deleted from the system before the registration deadline. If they are not deleted from the system they are considered as participating athletes and their entry fee shall be paid in full, even if they do not show up to the event.

#### 10.6 Competition Rules

The World Para Taekwondo Competition Rules as of November 23, 2021 will be implemented for the Para Taekwondo competitions of the K40 Sport Classes.

Please note that Article 10.5 of the WT Para Taekwondo Competition Rules will be in effect. Athletes that fail weigh-in shall be disqualified. All athletes are required to be registered in the correct weight division by the end of registration deadline. Weight division will not be changed in the case the athlete does not pass weigh in.

#### 10.7 Field of Play Regulations

By accepting a European Taekwondo Union accreditation card, all accredited persons agree to comply with the Field of Play regulations applicable at European Taekwondo Union events.

## 10.9 Contest Time

The duration of contest shall be one round of five (5) minutes with thirty seconds (30) timeout for each athlete. In the case of a tied score after the completion of the five (5) minute round, round of one (1) minute will be conducted as the Golden round, after a one (1) minute rest period. No timeout can be taken during the Golden Round.

Each coach will be allowed to call for one (1) thirty (30) second timeout at any time during the one round contest.

The duration of contest may be adjusted to four (4) minutes or three (3) minutes upon the decision of the Technical Delegate for the pertinent Championships.

- Holder of a valid 2022 WT Global Athlete License
- Member of the National team of a pertinent Member National Association, recognized by European Taekwondo Union and World Taekwondo
- Holder of the nationality of the participating team
- Holder of a Para Taekwondo Dan issued by the WT or a MNA recognized 5- 1 Geup for Kyorugi events
- Athlete must go through International Classification in accordance with the WT Athlete Classification Rules and be assigned a Sport Class and Sport Class Status prior to the tournament. Athletes found Not Eligible (NE) will not be able to compete.
- 6. An athlete in order to be eligible for participation must be born in 2006 or before for Kyorugi events
- All competitors must prove their age by presenting their passport or identification card at the official weigh-in. For those athletes that are not adults, a written consent must be submitted (please find enclosed on the last pages) at the registration, signed by one of the parents or legal guardians, accepting their participation and all parts of the official invitation.

### 12.2 Refugee Eligibility Requirements

If a refugee wishes to compete at the Manchester 2022, he/she must submit through the MNA he/she belongs to the relevant request to European Taekwondo Union, by submitting the following documents:

- The eligible refugee athlete must have official refugee status before the entry deadline of the event, meaning that an athlete whose status is in process of examination will not be accepted to compete.

- The refugee certificate issued by either governmental authorities of current residing country or the UNHCR will only be accepted.
- In addition to the certificate, official endorsement letter from MNA of current residing country must be presented.
- To register the refugee athlete, the abovementioned required documents shall be submitted to the ETU Office at [info@europeantaekwoundunion.org](mailto:info@europeantaekwoundunion.org). All such requests are examined, by the relevant ETU Working Group, at a standalone basis per event. After the Group examines the request, ETU refers back with the outcome and if it is positive, then ETU registers the athlete at the event under the Refugee Team.

### 12.3 Coach Eligibility Requirements

- Minimum age of 18 years
- Holder of a valid 2022 WT Global Official License
- Coach is not allowed wearing Dobok. A formal outfit (suit/dress) is mandatory for semi-finals & finals.

#### 12.4.2 Medical Diagnostic Form

Medical Diagnostics Form through World Taekwondo Classification System (WTCS)

Medical Diagnostic Form has to be submitted for any NEW (N) or REVIEW (R) athlete registered for the tournament. Deadline for uploading MDFs to the WTCS is 2359 CET on April 18th, 2022. If no MDF has been submitted by this time the athlete will not be called for classification and cannot compete.

Following IPC Guidelines on data protection concerning athletes and personal classification information, World Taekwondo has in connection with IPC created the World Taekwondo Classification System (WTCS). World Taekwondo Classification System (WTCS) is the new WT online registration tool for MNAs to register their new athletes and add Medical Diagnostic Forms (MDF) and pictures to be seen by the WT.

Classification Evaluation Committee in order to determine if the new athlete is eligible for Para Taekwondo and meets Minimum Impairment Criteria (MIC). All athletes in the WTCS will require a WT License Number (GAL).

WTCS Account Policy – Each Member Federation must internally designate exactly one (1) primary user responsible for WTCS Account.

#### 12.4.3 Research

WT will conduct research in para taekwondo kyorugi competition performance factors. Injury surveillance research as well as research into athlete classification will also be conducted during the event.

#### 12.5.1 Applicable Medical Rules

The WT Medical Code, WT mouthguard, bracing, taping, padding and piercing rules are applicable, which all MNA participating this event must comply.

#### 12.5.2 Applicable Doping Rules

The WT Anti-Doping Rules and the WADA Anti-Doping Code are applicable. Compulsory random doping tests will be conducted among all athletes. World Taekwondo and/or WADA may carry out random out-of-competition testing prior to the event.

#### 12.5.3 Therapeutic Use Exemption

Athletes who take any substance or medicine listed in the “Prohibited List” of the WT Anti-Doping Rules and WADA Anti-Doping Code for therapeutic purposes are requested to submit TUE applications via ADAMS, together with the required medical information.

#### 12.6 Indemnities

It is the responsibility of each registering team to ensure that their athletes and team officials have filled out the indemnification forms correctly and have duly signed them, thereby indemnifying WT, ETU, the Organizing Committee and all other officials and athletes from any claims of injuries, losses or otherwise arising in the course of participation at the European Taekwondo Championships | Manchester 2022 or any activities linked therewith.

It is the responsibility of each registered team to ensure and guarantee that sufficient insurance coverage has been arranged for all athletes, team officials and other participants. Without sufficient insurance coverage, teams will not be allowed to compete.

Please fill out the Personal Indemnity Forms and return them to the Organising Committee before the deadline. Each participant (athletes, team officials, etc.) has to fill out the indemnification form.

#### 12.7 Medical Insurance

All participating athletes, coaches, team officials, technical officials and participants at ETU events shall have mandatorily an international medical insurance that covers medical care

(COVID included) and in case of emergency, repatriation to the country of origin, valid on the days present in the host country of the event.

ETU nor the Organising Committee shall be responsible to cover any medical costs incurred for medical treatment before, on or during the competition or repatriation in the broadest sense of the word.

All relevant documents proving that such an insurance is present, including insurance policy papers, should be taken to the event in case a medical situation occurs.

Each MNA, Team doctor or team medical staff must ensure their athletes and team officials have valid international health insurance that covers medical and emergency care at the designated hospitals in UK before arrival to the venue.

### 13. Covid-19 Information

Due to the changing nature of restrictions and guidance related to travel and testing during Covid-19 the Organising Committee has committed to following guidance published by the UK Government.

The European Championships is taking place in Manchester, England and therefore the specific guidance published for England applies.

The information contained in the outline is accurate as of Monday 21 February 2022.

If any guidance or legislation changes before the event the Organising Committee, in conjunction with ETU, will communicate to the participating teams what this means to them, and any impacts or considerations.

#### 13.1 Entering and Exiting the UK

The latest guidance on entering and exiting the UK during Covid-19 can be found here: <https://www.gov.uk/guidance/travel-to-england-from-another-country-during-coronavirus-covid-19>

A key difference in the requirements for travelling to the UK is based on vaccination status. Individuals who qualify as 'fully vaccinated' do not need to take Covid-19 tests before travelling or after arriving in the UK. You must still complete a Passenger Locator Form 48 hours before arriving in England.

The next section outlines the different requirement for fully vaccinated and not fully vaccinated visitors to the UK.

**The European Taekwondo Championships 2022 does not require attendees to be fully vaccinated.** However, the OC does encourage Teams, athletes, and other attendees to consider the health of others, and the potential implications of not being fully vaccinated relating to travel, testing and isolation.

### 13.1.1 Fully Vaccinated

What you need to do when you travel to England from abroad depends on whether you qualify as fully vaccinated or not.

To qualify under the fully vaccinated rules for travel to England, you must have proof of vaccination with a full course of an approved vaccine.

You must have had your final dose of the vaccine at least 14 days before you arrive in England. The day you had your final dose does not count as one of the 14 days.

Before you travel to England you must complete a [passenger locator form](#). You need to do this in the 48 hours before you arrive in England.

You do not need to take any COVID-19 travel tests before you travel to England or after you arrive.

You do not need to quarantine when you arrive in England.

### 13.1.2 Not Fully Vaccinated

**Before you travel to England – not fully vaccinated**

**Before you travel to England you must:**

- take a COVID-19 test – to be taken in the 2 days before you travel to England
- book and pay for a COVID-19 PCR test – to be taken after you arrive in England
- complete a UK passenger locator form – to be completed in the 48 hours before you arrive in England

You will need to enter your PCR test booking reference number in the passenger locator form.

You do not need to quarantine when you arrive in England.

You must take the COVID-19 PCR test that you booked before you travelled.

You can take the test any time after you arrive and before the end of day 2 at the latest. The day you arrive in England is day 0.

If the test result is positive or unclear, you must self-isolate.

### 13.1.3 Quarantine and Isolation

This guidance is for people arriving in England from abroad who do not qualify as fully vaccinated under the rules for travel to England and either:

- get a positive or unclear result in their arrival PCR test
- do not take an arrival PCR test

#### **When you arrive in England – not fully vaccinated**

You do not need to quarantine when you arrive in England.

You must take the COVID-19 PCR test that you booked before you travelled.

You can take the test any time after you arrive and before the end of day 2 at the latest. The day you arrive in England is day 0.

If the test result is positive or unclear, you must self-isolate.

If you do not take the test, you must self-isolate.

#### **Positive test result**

If your test result is positive, you must self-isolate immediately. The standard self-isolation period is 10 full days. The day you took the test is day 0.

You can stop self-isolating on day 6 if you do a rapid lateral flow test on days 5 and 6 of your self-isolation period and:

- you do the tests at least 24 hours apart
- both tests are negative
- you do not have a high temperature

#### **Unclear test result**

If your PCR test result is unclear, you must self-isolate for 10 full days. The day you took the test is day 0.

You can choose to take another private test. If the result of that test is negative, you can stop self-isolating. If the result is positive, you must follow the rules for a positive test result.

**If you do not take the test**

If you do not take the test, you must self-isolate for 14 full days from the day after you arrive in England.

### 13.2 Responsibilities and Obligations of the Organising Committee

The Organising Committee has appointed a Covid-19 Health and Safety Officer. This person is responsible for ensuring all OC planning and operations consider how to minimise the risk of Covid-19 in line with the applicable UK Government guidance and legislation.

The Organising Committee has appointed a Covid-19 Medical Officer. This person is responsible for monitoring the medical health of any accredited person who tests positive or comes into contact with Covid-19 whilst travelling to or attending the event.

The Organising Committee can facilitate Covid-19 tests on arrival in the UK for individuals who are not fully vaccinated. These tests must be paid for before arriving in the UK.

The Organising Committee can facilitate Covid-19 tests for departure for individuals and teams who require them. These tests must be paid for before arriving in the UK.

The Organising Committee will make available an appropriate amount of Personal Protective Equipment (PPE) and hygiene/cleaning products for the tournament in line with UK Government guidance.

The Organising Committee will not underwrite the cost of any testing, medical or quarantine charges for visiting Teams. These costs are the sole responsibility of the Teams.

### 13.3 Responsibilities and Obligations of Teams

Participating Teams shall bear all costs relating to testing, medical treatment, quarantine and any changes to travel and accommodation bookings as a result of Covid-19.

Participating Teams shall bear all costs relating to the provision of PPE beyond the amount provided by the Organising Committee.

Participating Teams are responsible for knowing and complying with any testing and travel requirements for return to their country of origin, and for meeting any costs related to fulfilling these requirements.

## 13.4 Testing

### 13.4.1 Arrival Testing

Any Team members who need to take a Covid-19 test on arrival must book their test through the Organising Committee. This means the Covid Health & Safety and Medical Officers can verify the testing provider is on the UK Government approved list, and that the testing procedure is properly followed.

All test costs are the responsibility of the Teams and must be paid in full before arriving in the UK. Any additional testing costs incurred after arriving in the UK will be charged to the Teams and an invoice provided for immediate payment.

The Organising Committee will contact Teams at the start of April to assess arrival and departure testing requirements.

### 13.4.2 Departure Testing

Any Teams or individuals who need to take a Covid-19 test in order to return to their country of origin can book this test through the Organising Committee.

The Organising Committee will contact Teams at the start of April to assess arrival and departure testing requirements.
