# **PARTICIPATION REQUIREMENTS:**

- 1. Must have the National ID of the country you are representing.
- 2. Must be Competition sanctioned by the National Federation
- 3. Must have WT Global Athlete License 2023 (GAL).
- 4. Must have WT Coach Certification

#### **AFFILIATES:**

Every participant must be a citizen of the country he/she is representing. There must also be a letter of approval from the corresponding National Federation.

## **COMPETITION RULES:**

World Taekwondo Poomsae Rules will be followed.

## Recognized Poomsae:

Under 30 and Under 40: Single elimination tournament system. Two Poomsae performed for all rounds.













All other divisions: Contestants shall perform one (1) assigned compulsory Poomsae in the preliminary and semi-final rounds and two (2) assigned compulsory Poomsae in the final round. All contestants will compete in the preliminary round. The highest 50% scores from the preliminary round will advance to the semifinals. At the end of the semi-final round the highest eight (8) scoring contestants will advance to the final round. The highest score in four (4) contestants will be awarded medals (1st, 2nd, 3rd, 3rd) based on scores.

- Divisions with fewer than 20 contestants will start with the semi-final round.
- Divisions with fewer than 9 contestants will start with the final round.

  Designated poomsae forms will be drawn at the Poomsae Head of Team Meeting and posted online after the meeting.

# Freestyle Poomsae:

Poomsae Freestyle: Cut-off system for all Freestyle categories (single Final Round). The OC may change this due to organizational matters.

# Scoring shall be made in:

- -CONTEST TIME
- -ATHLETE ELIGIBILITY REQUIREMENTS
- -COACH ELIGIBILITY REQUIREMENTS

## **CONTEST TIME:**

Recognized Poomsae

Individual, Pair, and Team competitions up to 90 seconds. The waiting period between 1st poomsae and 2nd poomsae is minimum of 30 seconds.

Free Style Poomsae

Individual, Pair, and Mixed Team competitions from 90 seconds to 100 seconds.

The WT Technical Delegate has the authority to adjust the contest time as seen fit.

### ATHLETE ELEGIBILITY REQUIREMENTS:

- 1. Holder of a valid WT Global Athlete License.
- 2. Member of the team/club of a pertinent Member National Association, recognized by the Pan American Taekwondo Union or World Taekwondo.
- 3. Holder of 1st Dan/Poom, and above (WT regulations) for Cadet's athletes and above.

Contestants may compete in a maximum of two events per WT Competition Rules (in recognized poomsae and/or freestyle poomsae). If an athlete is registered in more than two events, the athlete will randomly be removed from the needed events until meeting the two limit criteria.

## **COACHES ELEGIBILITY REQUIREMENTS:**

The requirements are:

- 1. Must be 21 years old or above.
- 2. Must have WT Global Athlete License 2023 (GAL).
- 3. Coach is not allowed to wear a Dobok.













### **COACHES DRESS CODE:**

Formal wear is mandatory for all coaches during semifinals and finals.

#### SPORTS EQUIPMENT:

Mats: WT Recognized mats will be used at the event Dobok.

Approved Poomsae Competition Uniforms

Children Division (6-11): Color code as Cadets is highly encourage, but participants may compete in fully white V neck dobok.

Division (Ages 12-14): White top with red and black collar, plus blue pants for males; the same top, but with red pants, for females.

Junior and Senior Division (Ages 15-50): White top with dark blue pants for males; white top with light blue pants for females.

Master Division (Ages 51 and up): Yellow top and dark blue pants for both males and females.

## **REGISTRATION METHOD AND DEADLINE:**

Early registration starts: APRIL 1<sup>ST</sup>, 2023 at 00:01am Costa Rica time. Early registration deadline is: APRIL 30<sup>th</sup>, 2023 at 23:59pm Costa Rica time. Regular registration deadline is: MAY 31<sup>ST</sup>, 2023 at 23:59pm Costa Rica time. Late registration deadline is: JUNE 12<sup>th</sup>, 2023 at 23:59pm Costa Rica time.













# NO SHOW POLICY:

Athletes who do not show up for registration and have not previously notified that they will not participate in the event before the early registration deadline, must pay their registration fee. Only cancellations with a medical certificate will be accepted after this date, if there is no legal medical document, the corresponding payment must be made, Deadline June 01<sup>th</sup> 2023.

#### **REFEREES:**

- 1. Pan American Taekwondo Union (PATU) will designate the number of refrees required.
- 2. Each international Referee must cover their own plane tickets.
- 3. Five nights of room, board and meals will be covered by the OC (Check In: june 14th, 2023 / Check Out: june 19<sup>th</sup>, 2023).
- 4. The OC will pay an honorary of \$150 USD for the four days of competition.

#### **MEDICAL SERVICE:**

- 1. The OC will provide medical services only in emergency where a participant is injured.
- 2. Participants will be responsible for all expenses incurred from injury and/or hospitalization.
- 3. The OC recommends to the participant they have medical insurance and have all documents on hand.

## **VISA INFORMATION:**

The payment for the competition is to be made at the registration office in cash only. Registration will take place at the Best Western Irazú from June 12th - 14th, 2023 and at the venue (Palacio de los Deportes de Heredia) from June  $15^{th} - 18^{th}$ , 2023.

## **PAYMENT METHOD:**

All participants will be responsible for obtaining the necessary visas. The invitation letter is available at request by writing to opencostaricatkd@gmail.com by no later than april 20<sup>th</sup>, 2023.

## AWARDS:

- 1. All athletes will receive a Certificate of Participation.
- 2. Awards: World Ranking G-2 / G-2.
  - a. A best male and female Referee Open trophy will be awarded, Poomsae & Kyrougi.
  - b. A best male and female athlete Open trophy will be awarded G-2 Poomsae.
  - c. A best male and female coach Open trophy will be awarded G-2 Poomsae.
  - d. A 1<sup>st</sup>, 2<sup>nd</sup> and 3er place Open trophy will be awarded G-2 Poomsae.

### **Ground Transportation:**

Ground transportation must be provided by every national team, only for teams who book via the official hotel website or hotel phone the Organizing Committee via the host hotels will provide airport - hotel airport transportation, time and flight number of the national team's arrival and departure must be provided to the host hotels at the latest by the designated deadline (August 16th, 2022). During the event there will be transportation to the venue from the official Hotel only for those who book and pay their accommodation through the Hotel Manager (Reservations through: Booking, Expedia, Trivago, etc. will not be accepted to shuttle Airport-Hotel-Competition Venue).













## **CREDENTIALS:**

CRCTKD has a NO REFUND policy.

Athletes will receive an event credential via email if they have paid in full by the registration deadline. If an athlete has not paid in full, they must come to the registration desk onsite to complete any outstanding items with their profile before they will be emailed a credential.

Coaches will not be emailed a credential. All coaches will receive a physical credential onsite at the event. All participants must provide a valid ID to weigh-in. There will be no exception to this policy. A valid ID can be any of the following: school ID, state issued ID, GAL, or passport. If the athlete is a minor and does not have a valid ID then the parent/legal guardian must provide a copy of their birth certificate.
