2. QUALIFICATION

Condition of Participation: Participants must be member of a National Taekwondo Federation, affiliated to the WT. This membership must be proved by the WT license for all officials and competitors.

- All Athletes and Officials must hold a valid 2024 WT Global Licence
- It is NOT possible to register on the SITE without a WT License!
- An Invalid or unknown WT License number will result in disqualification for the coach and/or competitor.
- Entry fees are obligated at all times.
- The WT license is the responsibility of all participants (competitors and officials)
- All contestants have to proof their age and nationality by presenting national ID or passport at weigh-in.
- Those who are not recognized as adults by law in their own country must submit a passport or identification card together with a written consent (Liability declaration) of their parents or lawful guardian accepting their participation and all parts of the official invitation.

3. RULES

Competition rules: For this competition it will be use **Daedo PSS electronic**.

The Organizing Committee will provide Protector and Scoring System (PSS) and the head protector to the participating contestants. Participating contestants are required to bring their own groin guards, mouthpieces, gloves, sensing socks and shin and forearm guards for their personal use.

Before entering the field of play, all contestants will proceed to the inspection desk for inspection of their doboks and protective equipment. Any contestant who wears unofficial doboks or protective equipment will not be permitted to compete.

Instant Video Replay (IVR) System will be used.

Weight in: It will be done follows the rules and regulation of WT update on 2024.

- Weight it is set one day previous Championship on sharp see the time table schedule,
- Random weight it is set following procedure in the day of competition (07:30 to 08:30)

Doping control: Following WADA rules, by Romania Anti Doping Agency.

- The 1st to 3rd place winner of each weight division it will subject to be doping tested chosen randomly.
- The list of prohibited products will be the same as the IOC and WT update lists.

Venue Rules:

- Only the competitors and their coaches have admittance by the registration cards to the contest areas.
- Coach must have minimum age of 18 years and registered as coach or trainer;
- Holder of the WT Coach License Level I Coach Certification;
- Holder of a valid 2024 WT Global Official License;

- One (1) coach for every (5) competitors has free admission maximum of four (4) coaches per team.
- Coach only in sportswear (no Dobok).

Uniform and Equipment:

We would like to remind you that use of WT-recognized (WT approved) uniform and equipment by the Organizing Committee as well as all participating athletes is a “MUST” in accordance with the following provision of the WT Competition Rules:

Article 4. Contestant

4.2 Contestant uniform and competition equipment

4.2.1 At the competitions enlisted in the WT Event Calendar, contestant uniform and all competition equipment but not limited to mats, PSS, IVR and protective equipment must be those ones approved by the WT.

4. AWARDS

Awards:

Medals will be awarded for 1st, 2nd and two 3rd place medals in all categories.

Trophies for the best athlete

Trophies will be awarded for the first 3 teams

Fair play trophy.

Trophy for the best two referees.

All participants will receive a certificate of participation.

All athletes participating in this championship will receive international points in the WT ranking.

5. ENTRY

Regular entry fee:

100 € (or equivalent in US Dollars) per competitor for every applied competitor. Entry fee must be transferred to the account below until the deadline by 1th of September 2024 without any costs for the organizer. Cost of any payable fees will no refund.

125 € per competitor for every applied competitor. Entry fee must be transferred to the account below until the deadline by 10th of October 2024 without any costs for the organizer.

150 € per competitor for every applied competitor if paid in cash at the registration.

If the athlete registered online (<https://worldtkd.simplycompete.com/>) does not take part in the competition for some reason, but he/she has not been removed from the list of participants before the deadline (01.10.2024.), his/her team official must fully (100%) pay his/her entry fee for

participation. Entry fee is not refundable at any time after the deadline! In case of no show the invoice will be send to the team after the tournament.

Protest: An amount of €200,00 - will have to be paid for each protest.

- Only the official coach is allowed to protest at the Board of Arbitration immediately (within 15 minutes) after the end of the relevant contest.

NOTE: All payments by bank transfer have to be done without any deduction of expenses! Any costs of the bank transfer (non - Euro zone) will be charged.

IMPORTANT: Application is only valid when payment has been done at the same time of registration. Applications are only valid when payments of all entree fees have been received within 3 days. If payment is not received within 3 days the application will be removed from our register.

7. OTHERS

Referees: Referees must be licensed by WT.

Conditions For Referees: Round trip airfare should be paid by each participating referee. The Organizing Committee will provide accommodation with the full board

National flag:	Each participating team should bring two delegation flags with size 90 cm x 130 cm and a CD with their national anthem.
Video recording:	Recording within the competition area is not allowed. Recording from the public stands is only allowed for handy cam - type cameras.
VISA:	<p>All participants must check the visa requirements for entering Romania and apply in good time at the consulate of the Romanian Embassy designated for that country. The Organizing Committee will assist all visa applicants by issuing a one-time visa invitation letter the accommodation reservation is completed. Unfortunately, OC doesn't have the ability to expedite visa applications or to contact embassies on behalf of visa applicants. 8. DOPING

Applicable medical rules

The WT Medical Code, WT mouth guard, bracing, taping, padding and piercing rules are applicable, which all MNA participating this event must comply.

Applicable doping rules

The WT Anti-Doping Rules and the WADA Anti-Doping Code are applicable. Compulsory random doping tests will be conducted among all athletes.

Therapeutic Use Exemption

Athletes who take any substance or medicine listed in the "Prohibited List" of the WT Anti-Doping Rules and WADA Anti-Doping Code for therapeutic purposes are requested to submit TUE applications via ADAMS, together with the required medical information.

10. Indemnification

11. Medical Insurance

All participating athletes, coaches and team officials shall have mandatory a medical insurance that covers medical care and in case of emergency repatriation to home country. All relevant documents proving that such an insurance is present, including insurance policy papers, should be taken to the event in case a medical situation occurs.

12. LIABILITY

All participants take part on their own risk. The organizer is in no way responsible for any damage caused to a person or their belongings. With the registration the participant/club acknowledges and accepts all the listed points.

CLASS B TOURNAMENT: WILL USE WT COMPETITION RULES FOR KYORUGI

- *Single elimination tournament system qualification.
- * There is no change in age group and weight class.
- *In this class, the OC will allow any participant to participate in the championship if they hold at least 8 KUP up to 5 KUP.
- *GAL/GOL is not required in this class.
- *No hitting to the head is allowed.
- *All athletes are required to wear a Masks and dental protection.
- *All contestants have to proof their age and nationality by presenting national ID or passport at weigh-in.
- * Registration for Class B will be done through the Romanian Taekwondo Federation, see the guide form.
