## 8. GENERAL ELIGIBILITY REQUIREMENTS

Each MNA can send one (1) athlete per weight category to compete in the European Junior Championships 2025 weight divisions.

## 9. ELIGIBILITY REQUIREMENTS

1. Holder of the Nationality of the participating team.
2. An athlete must be nominated by the pertinent national taekwondo association that is recognized by European Taekwondo Union and World Taekwondo
3. Holder of 1st Geup and above.
4. An athlete must be born between 1 January 2008 and 31 December 2010
5. Holder of an approved 2025 WT Global Athlete License (GAL) \*\*\* Any questions on the WT GAL, please contact your assigned WT GMS Manager
6. In case of a Refugee athlete, the athlete must meet following Requirements.
  - a. Must hold the Refugee Status, documented by UNHCR or
  - b. Refugee Status documented by national agency, e.g. Department of Foreign Affairs or related/responsible department of the residing country.
7. In case of an Individual Neutral Athlete (AIN), the athlete must
  - a. Obtain AIN Status, screened and confirmed by World Taekwondo.
  - b. Only athletes with AIN GAL Number can participate.

## 10. COACH ELIGIBILITY

1. Minimum age of 18 years.
2. WT Coach Certificate Level I or above is required.
3. Holder of a valid 2025 WT Global Official License.
4. Coaches are not allowed to wear Dobok. **A formal outfit (suit/dress) is mandatory for semi- finals & finals.**
5. 1 coach per 5 athletes is allowed.  
Exceeding this ratio is subject to an extra fee.

## 11. METHOD OF COMPETITION/ CONTEST TIME

Single Elimination tournament system

Best of three (3) system will be used

3(2) rounds of 2 minutes, 1 minute break between each round.

## 22. APPLICABLE FEES

**REGULAR REGISTRATION FEES:** National teams that complete their payment during this period will be charged the regular registration fee.

- Registration Fee: € 150 EUR per athlete.
- Registration Period: Paid until to October 31, 2025, 17:00 Local Swiss time.

**LATE REGISTRATION FEES:** National teams that complete their payment during this period will be charged the late registration fee.

- Registration Fee: € 175 per athlete.
- Registration Period: Paid from October 31, 2025, 17:01 local Swiss time.

**CASH PAYMENTS (not recommended) 200 euro per registered athlete.**

**ON-SITE OF CHANGE OF MEDAL EVENT (weight division)**

Medal events (weight divisions) cannot be changed after the entry deadline of 23:59 CET on 31 October 2025.

**ADDITIONAL ACCREDITATION CARDS**

50 euro for each on-site approved additional requested Accreditation card or for every accreditation on the top of the above-mentioned quotas.

**ADDITIONAL COACHES**

50 euro for each on-site approved additional requested Accreditation card exceeding this ratio 1 coach per 5 athletes.

**PROTEST FEE**

200 euro. In case of an official protest submitted according to WT Rules, a non-refundable 200 euro fee shall be paid. Make sure the protest form is used (attached at the end) and be aware that the protest is made in time.

### REPLACEMENT OF ACCREDITATION CARDS

50 euro for each replacement and reprinting request of accreditation cards.

### REPLACEMENT OF ATHLETES

In case an athlete needs to be replaced after the deadline, this can be done maximum 48 hours before the draw will take place. A fee of 150 euro is applicable.

## 24. PROOF OF PAYMENT

All teams are required to send proof of payment (copy of bank transfer) to [finance@europetaekwondo.org](mailto:finance@europetaekwondo.org) within one (1) week after registration in Simply Compete or submit it at the registration appointment booking platform. European Taekwondo Union has the right to delete sport entries from teams that do not send proof of payment from the system in order for other athletes to register and to prevent 'ghost athletes'.

Any athlete registering on-line who does not take part in the competition and who has not been removed from the entry list before the deadline October 31, 2025, is fully liable for paying his/her entry fee in full. (For any athlete not presenting at registration, his/her team or official shall be liable for ensuring full payment of the entry fee of the aforementioned athlete prior to the team's participation). If a team does not show up at the event and has not requested a participation cancellation before the deadline, ETU shall invoice the team for the full amount (100%) as per current outline.

## 25. NO REFUND

European Taekwondo Union and/or the Organizing Committee do not refund entry fees paid. In case of an event amendment, postponement or cancellation, the teams/athletes paid their entry fees get a voucher of the same value to be used in future ETU events only.

## 28. MEDICAL CONTROL AND ANTI-DOPING

1. The WT Anti-Doping Rules, and where necessary the Code of the World Anti-Doping Agency, shall apply throughout the competitions.
2. Compulsory anti-doping tests will be carried out for all medalists as well as random selection basis. The WT and/or WADA may carry out random out-of-competition testing prior to the competition.
3. TUE (Therapeutic Use Exemption) Athletes who take any substance or medicine listed in the "Prohibited List" of the WT Anti-Doping Rules and Anti-Doping Code of World Anti-Doping Agency (WADA) for therapeutic purposes are requested to submit TUE applications via ADAMS, together with the required medical information. If you do not have an ADAMS account yet, please contact [tue@ita.sport](mailto:tue@ita.sport) to have it set up. Otherwise, please download the TUE

To be provided in due course. Teams and individuals requiring a visa to enter Switzerland must note that there is no option for a Visa-on-Arrival application. All participants must check the visa requirements for entering Switzerland and apply in advance through the form below.

The Organizing Committee will issue an official invitation letter once the accommodation booking is completed.

To apply for a visa, the following documents are required enclosed to the VISA Application Form:

- Passport copy
- Personal photo
- Global license

**All documents must be renamed with the applicant's full name; otherwise, the request will be ignored.**

#### Important Notes:

- Visa applications must be submitted as a single request for all team members.
- The deadline for visa application submission is October 10.

### 33. IDEMNITIES

It is the responsibility of each registering team to ensure that their athletes and team officials have filled out the indemnification forms correctly and have duly signed them, thereby indemnifying WT, ETU, the Organizing Committee and all other officials and athletes from any claims of injuries, losses or otherwise arising in the course of participation at the European Junior Championships 2025 or any activities linked therewith.

It is the responsibility of each registered team to ensure and guarantee that sufficient insurance coverage has been arranged for all athletes, team officials and other participants. Without sufficient insurance coverage, teams will not be allowed to compete.

Please fill out the Personal Indemnity Forms and return them to the Organization Committee before 31st October 2025. Each participant (athletes, team officials, etc.) has to fill out the indemnification form.



### **34. MEDICAL INSURANCE**

All participating athletes, coaches, team officials, technical officials and participants at ETU events shall have mandatorily an international medical insurance that covers medical care (COVID included) and in case of emergency, repatriation to the country of origin, valid on the days present in the host country of the event. ETU nor the Organizing Committee shall be responsible to cover any medical costs incurred for medical treatment before, on or during the competition or repatriation in the broadest sense of the word.

All relevant documents proving that such an insurance is present, including insurance policy papers, should be taken to the event in case a medical situation occurs. Each MNA, Team doctor or team medical staff must ensure their athletes and team officials have valid international health insurance that covers medical and emergency care at the designated hospitals in Switzerland before arrival to the venue.

#### **GENERAL**

The OC cannot predict the developments in the next coming months with regard to the Corona COVID-19 outbreak in Europe. The teams have to bear in mind that due to the uncertain nature of the Corona COVID-19 outbreak and sole authority of each government on how to respond, restrictions to access the Host country may be applicable.

It is the responsibility of each and every participating team to make sure they meet all entry requirements in order to enter the Host country and to monitor the Swiss policy with regard to entry policies.

#### **SUFFICIENT INSURANCE**

The teams are strongly urged and advised to make sure to have their own sufficient travel, cancellation, medical insurance.

#### **LIABILITY**

In this respect, please be informed that the OC shall not and cannot be held liable for any expenses and costs incurred by the teams for travelling to the event in case of cancellation of the event due to (further) outbreak of the Corona COVID-19 virus in the Host Country. The teams are strongly urged and advised to make sure to have their own sufficient travel, cancellation and medical insurance. The OC shall not accept any claims or requests for compensation in case of cancellation of the event.
