In accordance with *Article 4: Qualification of Contestant* of the WT Competition Rules, the contestant must be:

**CRITERION #1:** Participating contestant must be women.  
**CRITERION #2:** Holder of the nationality of the participating team.  
**CRITERION #3:** Holder of the Kukkiwon Poom or Dan Certificate.  
(\* A copy of the Poom certificate should be enclosed when registering for accreditation. In case a contestant has applied for a Kukkiwon Poom certificate but has not received it yet, a copy of the Poom application form and the remittance certificate sent to the Kukkiwon must be enclosed when registering for accreditation. Please refer to the Kukkiwon Website ([www.kukkiwon.or.kr](http://www.kukkiwon.or.kr)) for more information.)  
**CRITERION #4:** An athlete must be 17 years old or older in the year of the Taiyuan 2026 Women's Open Championships. Athlete who was born in 2009 or before is eligible to participate in the competition.  
**CRITERION #5:** Holder of an active WT Global Athlete License (GAL)

## 7. METHOD OF COMPETITION

- i. Single elimination system
- ii. Grade: G-4
- iii. Number of athletes: No limit.
- iv. Seeding and drawing of lots: For every weight category, regardless of number of athletes all the athletes will be seeded based on the WT World Ranking published in August, 2026.

## 8. CONTEST TIME

Best of 3 system [2 minutes x 3(2) round with 1 minute break]

## 9. CONDITIONS FOR PARTICIPATION

Round trip airfare and accommodation charges of room and board shall be borne by the participating National Association.

- i. All athletes and Team officials must first be registered with a WT Global Athlete License (GAL) or Global Official License (GOL).
- ii. Online National Team Entry will only be accepted through the WT online registration system, <https://worldtkd.simplycompete.com> and registration is only possible with an approved WT Global License. MNA assigned GMS admins will be notified via email once online registration is open.
- iii. Entry submission for the athletes after the deadline will not be accepted under any circumstances. Changes to weight categories after the entry deadline will also not be permitted.
- iv. Athletes and team officials registered online may be replaced without penalty before the **close of the final online registration period**.
- v. Registration fee will not be charged for cancellation of participation before the **close of the final online registration period**.
- vi. Registration fee must be paid in full in case of cancellation of participation of registered athletes after the close of the final online registration deadline or in case of no-show. The applicable registration fee to be paid may vary depending on the registered period in which the athletes was registered.
- vii. Team officials can hold ONLY one position, holding multiple positions (roles) is not allowed.
- viii. Additional Penalty: Penalty of US\$100 per person shall be paid to the Organizing Committee at the accreditation center in the following cases:
  - A team official who is not registered online but seeks accreditation onsite, even if the

- total number of team officials does not exceed the designated limit.
- Any changes or additions that are made to a team entry list (except for contestants) after the close of the final online registration period will incur a US\$100 penalty. This penalty will be considered the onsite fee for approved changes or additions to the team entry list.
  - Any changes or additions made to a team entry list (except for contestants) after the online registration has closed MUST be approved in person by the Head of Team or Manager. If no Head of Team or Manager is registered for the event, then written confirmation from the MNA President, Vice President, Secretary General or GMS Administrator will be required.
  - Re-print Penalty: Penalty of US\$50 per accreditation shall be paid to the Organizing Committee at the accreditation center for any re-printing of accreditation cards due to loss of accreditation.
- ix. **Any WT Global Licence registration completed onsite will incur a US\$50 onsite processing fee per WT Global Licence required.**

\* At the close of regular registration on July 29, 2026, at 17:00 (local Swiss time), WT and the Organizing will decide whether to implement an extension of the registration period. ## **13. LATE ATHLETE REPLACEMENT**

- i. Late Athlete Replacement due to injury shall be handled case by case.
- ii. The team wishing to replace an athlete after the regular registration deadline must complete the Late Athlete Replacement Form attached to this outline and submit it to the WT Sport and Event Management Department at [sport@worldtaekwondo.org](mailto:sport@worldtaekwondo.org) no later than **August 25, 2026, at 14:00 (local time)**. Please note that replacements are only permitted within the same weight category. No requests for replacement will be accepted after the deadline.
- iii. Please refer to the appendix for the Late Athlete Replacement form.

## **14. WEIGH-IN**

- i. General weigh-in of the contestants shall take place on the day before their respective weight category.
- ii. Random weigh-in of the contestants shall take place in the morning on the competition day of their respective weight category except W+73.
- iii. Random weigh-in shall take place to following number of athletes with 5% allowance as below tables.
- iv. During the weigh-in, female contestants shall wear underpants and brassier. However, contestants may weigh-in in the nude if they want to do so.

### 16. WT-RECOGNIZED TAEKWONDO COMPETITION UNIFORM AND PROTECTIVE EQUIPMENT

- Waychamp Protector and Scoring System (PSS)** including Head PSS will be used for the competition.
- Participating contestants are required to wear WT-recognized **Kyorugi competition uniforms** and WT-recognized protective equipment. The latest version of WT-recognized manufacturers' list is available at the website of WT.

- The Organizing Committee will provide the Protector and Scoring System (PSS) for the

participating contestants. Participating contestants are required to bring their own groin guards, mouthpieces, gloves, sensing socks and shin and forearm guards for their personal use.

- iv. Before entering the field of play, all contestants will proceed to the inspection desk for inspection of their **competition uniforms** and protective equipment. Any contestant who wears unofficial **competition uniforms** or protective equipment will not be permitted to compete.
- v. The top has to cover completely the buttocks. However, the bottom of top should be more than 15cm above the knee cap.
- vi. Instant Video Replay (IVR) System will be used.

### **17. SENSING GLOVES APPLICATION AND ALTERNATIVE JUDGING PROTOCOL**

- i. Sensing gloves will be used at the Taiyuan 2026 World Taekwondo Women's Open Championships. With the implementation of sensing gloves, only one Corner Judge will officiate to determine the validity and accuracy of all technical actions and to award points. In the event that sensing gloves are unavailable for use at this event, two Corner Judges shall officiate the contests.

### **18. IDENTIFICATION OF NOC CODE AND MANUFACTURER**

- i. The national flag shall be positioned between 3 cm and 3.5 cm below the shoulder line on the right sleeve.
- ii. The NOC Code shall consist of the three-letter abbreviation of the respective National Olympic Committee. It shall be printed in black, in bold "Verdana" font, on the back of the upper garment. The NOC Code shall be centered and positioned at least 5 cm above the bottom edge of the upper garment. The size of the NOC Code shall be 30 cm (width) × 12 cm (height).
- iii. Manufacturer identification (name, trademark, logo, or other distinctive signs of the manufacturer) shall be permitted as follows:
  - One (1) identification on the top of the Kyorugi competition uniform, not exceeding 30 cm<sup>2</sup>, positioned between 3 cm and 3.5 cm below the shoulder line on the left sleeve;
  - One (1) identification on the bottoms of the Kyorugi competition uniform, not exceeding 30 cm<sup>2</sup>, positioned above the knee and centred on the right leg;
  - One (1) identification on the Kyorugi belt, not exceeding 6 cm<sup>2</sup>, positioned at one end of the belt.

### **19. SPONSOR'S IDENTIFICATION**

- i. One (1) sponsor identification (logo) shall be permitted on each of the top and bottoms of the Kyorugi competition uniform.
- ii. Each sponsor identification shall not exceed 50 cm<sup>2</sup> and shall be placed in a location other than those reserved for the WT logo, manufacturer identification, national flag, and NOC code.

### **20. MEDICAL CONTROL**

- i. The WT Anti-Doping Rules, and where necessary the Code of the World Anti-Doping Agency, shall apply throughout the competitions.
- ii. Compulsory anti-doping tests will be carried out for all medallists as well as random selection basis. The WT and/or WADA may carry out random out-of-competition testing

- iii. TUE (Therapeutic Use Exemption)  
Athletes who take any substance or medicine listed in the “Prohibited List” of the WT Anti-Doping Rules and Anti-Doping Code of World Anti-Doping Agency (WADA) for therapeutic purposes are requested to submit TUE applications via ADAMS, together with the required medical information. If you do not have an ADAMS account yet, please contact [tue@ita.sport](mailto:tue@ita.sport) to have it set up.  
Otherwise, please download the TUE Application Form [HERE](#) and once duly completed and signed, send it together with the required medical file to [tue@ita.sport](mailto:tue@ita.sport) with copy to [antidoping@worldtaekwondo.org](mailto:antidoping@worldtaekwondo.org). by at least 30 days before the first competition day. ### **21. HEAD OF TEAM MEETING & DRAWING OF LOTS**

- i. The Head of Team Meeting shall be conducted two (2) days prior to the start of the 1st day of competition that is **August 26**, in the presence of the WT officials and the representatives of the participating nations.
- ii. At least one representative from each team must attend the head of team meeting. In case of no representative can be at the meeting, the team must designate a proxy and inform technical delegate or WT Sport & Event Management department before the meeting.
- iii. Drawing of lots will take place each day following the completion of General Weigh-in. Draw will be published on WT website within four hours after the Weigh-in.

### **22. INDEMNITIES**

- i. The respective national taekwondo associations shall be responsible for ensuring that all officials and participants are covered with effective travel & medical insurance coverage.
- ii. Participants without proper insurance coverage will not be allowed to compete at the competition.
- iii. The Organizing Committee will acquire general Public Liability event insurance.

### **23. ACCOMMODATION & TRANSPORTATION**

Accommodation guide will be available on the WT GMS. All accredited teams participating at the event shall book their hotel accommodation via the Organizing Committee. The participating teams are required to submit the Accommodation / Transportation booking form to the Organizing Committee by email [gm-office@jjinsports.com](mailto:gm-office@jjinsports.com) no later than August 17th.

### **24. VISA INFORMATION**

The Organizing Committee can provide invitation letters for visa applications. However, MNAs are required to check the China entry visa application waiting times in their own countries and submit requests for invitation letters to the Organizing Committee. The visa invitation letter from OC will be sent within 7 working days after request. The Organizing

Committee cannot guarantee entry into China and can only offer assistance. It is the responsibility of each athlete and MNA to apply for and secure the correct entry visa for China. MNAs are requested to complete the attached visa application form at least one week before the waiting time deadline in their own country.

### **25. COACH'S REQUIREMENTS**

**All coaches are required to hold a WT Coach Certificate Level II (2).** Coaches who do not hold a Level II Coach Certificate will be removed from the registration list and will not be permitted to coach at the relevant competition.

All coaches are required to wear formal suit such as tie, jacket, dress shirt (long- or short-sleeved), and trousers, and sport shoes during Semi-Finals and Finals. Caps, hats of any kind, and shorts shall not be permitted when entering the Field of Play. Any coach who fails or refuses to comply with the above dress requirements shall not be permitted to coach at the competition.

### **26. TEAM DOCTOR'S MEETING**

In order to receive accreditation card, all registered team doctors or physicians must attend team doctor's meeting on **August 26, 2026**.
